Annual Dues and Spring Renewals

This month of April closes out the payment cycle of the Annual Dues and Assessments and its 6-month payment plan. This balance was required to be fully paid by March 25th, 2024. Your April 1, 2024 billing statement will include the billing of your renewal charges, specific to your site for the 2024 season (Prox card renewals, boat and golf cart stickers, and internet or pump-out plan requests), as well as your quarterly electric assessment and state unit tax. Each member's renewal information was uploaded and made available on the member portal for your review and approval. Payment of these renewal charges will be due on April 25th, 2024.

Bullpen & Flea Markets

Do not forget to reserve your bullpen and flea market spaces for this upcoming season. This can all be done on the Sandy Pines website. If you need some additional help or information, you can reach out to Member Service. Flea market spaces must be paid for at the time of booking they can no longer be charged to your member site at this time. Each space is \$45. Please refer to the website for any additional rules and regulations. Spaces can only be reserved by the member. Refunds are not available for cancellations. Bullpen paperwork can be found on the Sandy Pines website. The paperwork to reserve your spot can be sent in to Member Service where we will get you a bullpen storage number and a PIN for your in and out access. A friendly reminder the bullpen will start on the date that we receive the reservation information. Unfortunately, we do not reserve these ahead of time.

Mailbox Rental

If you are expecting deliveries this year at Sandy Pines, you

The fee will be part of your spring renewals each year you continue to have a mailbox. This should get you directly to where Spectrum can look up your information and provide you with service. If you have difficulties with them you can reach out to us in the Member Service Administration Department. We will gladly try to help you out.

Sticker Pick-Up

We will begin STICKER PICK-UP when we officially open the gates on April 15th, 2024. You will be able to come into the Administration office to pick up the stickers that you will need for the 2024 season. You will need to be a member at that

site and we will require an ID for sticker pick-up. Whether it be your Sandy Pines card or a driver's license. We will offer a couple of extra Saturdays for **STICKER PICK-UP ONLY** prior to our every Saturday summer hours. These prior dates will be Saturday, April 20th and May 4th, 2024. Hours will be 8 am – 12 pm. Officially we will start our everyday Saturday hours on May 11th, 2024.

BOARD OF DIRECTORS UPDATE

Hard to believe that SP version 2024 is just around the corner. In just a few short weeks, members will return to rekindle relationships and get things ship shape for the season. The list may be long but the reward is well worth it. Nothing better than tidying your little slice of paradise, making it an oasis of which you can be proud. For the vast majority, this is the case and makes for a beautiful Park.

Unfortunately, there are a few folks who, for whatever reason, fail to meet basic guidelines regarding cleanliness and clutter. Up until now, rule enforcement has been spotty and inconsistent. Many members have become frustrated with select neighbors allowing their sites to become eyesores, seemingly without sufficient Park intervention to correct them. We have listened to your concerns and are taking action moving forward.

Rules currently are in place to help control disarray, however there are shortcomings. For instance, do you realize that with current guidelines in place, you only have to maintain your lot until Labor Day? And, with the current fine/point penalty implementations, the process to force member cleanliness could continue past Labor Day. The Rules Committee was entrusted to delve into this matter and provide input and suggestions to the Board. The following is a synopsis of our present rules, plus a look at more stringent regulations that are being proposed with more bite. Suffice to say, what has been happening to date doesn't seem enough to curb the problem.

The official cleanup day will remain on June 10th. In the past, a violation after June 10th would result in a \$100 fine with zero points and 14 days to correct. Every 14 days thereafter, if the problem wasn't corrected, fines and points would accumulate with no end date. This means the issue could remain unresolved through Labor Day.....when you were no longer required to maintain your site. The result was a big fat zero.

The new proposed rules will keep the beginning date on June 10th but extend the cleanliness expectation through season-end. A violation after June 10th will now result in a \$200 fine and three points. If the situation is not corrected in 14 days, a second violation will be issued accompanied by

another \$200 fine and three points. Member and associate cards will be suspended until such time that the site has been satisfactorily cleaned. Having a total of six points can also result in membership review by the Board. As an aside, it should be noted that a second individual has been hired to work in the field of the inspector's office, easing the burden of a previously overworked, one-person department. Plus, the office will also have a new staff member to help with communication and allow Saturday morning hours. See the Park President's column this month for more details.

We sincerely hope and pray that no one reading this article will have to endure the rigors of multiple violations. That said, the Park spends countless hours keeping our Happy Place

beautiful. As do the vast majority of members. But there always seems to be that one place that we always cringe when passing by. We're also sympathetic to those with extenuating circumstances. Remember, there are clean-up personnel on the park contractor list as well as eager high school/college kids peddling their services via social media. Perhaps you could reach out to a neighbor, phone-a-friend as it were. The Park is loath to penalize and will do so only as a last resort. And I can assure you the Board takes no pleasure in passing more stringent laws with potential financial ramifications. Please, let's do our best to make the Park an aesthetically pleasing place. Spring Clean-Up Rules Update

As we gear up for the 2024 season, there are some changes to our Spring clean-up rules that I want to highlight. The Board of Directors will finalize these changes early in April, as they are crucial to maintaining the park's pristine appearance.

Here's a breakdown of the updated rules:

Members now have until June 10th to ensure their sites are clean. After June 10th, violations will be addressed as follows:

- · First violation: Members will have 14 calendar days to rectify the issue (by June 23rd). A \$200 fine will be imposed, along with 3 points added to the member's account.
- Second violation: Members will have 7 calendar days to correct the issue (by June 29th). An additional \$200 fine will be levied, along with 3 more points. At this stage, a membership review will be conducted, and all access cards will be deactivated.

With these new guidelines, all issues will be resolved by the July 4th Holiday, which is 76 days after the park's opening on April 15th. Our park is a collective investment and a happy place for all, so let's each do our part in keeping it in its best shape.

I look forward to seeing you all this season. Take the time to explore the numerous enhancements made over the winter. Welcome back and enjoy the season ahead!



The primary focus of this review is to ensure not only the financial stability of Sandy Pines in the upcoming season but also for the park's legacy in the years to come. As we approach the end of Capital Reserve funding, attention will be directed towards essential projects in the park's best interest. While several items have been budgeted for the future, the continuation of these projects will be contingent on the success of a new capital funding plan, a significant focus for the Finance Committee and Board of Directors, with membership approval, prioritizing the park's best interests.


Sandy Pines Board of Directors and Finance Committee members will meet in the month of April 2024 to review and approve the November 2023 through March 2024 Financial Statements. Approved financial statements can be accessed on the webpage at www.sandypines.com/members/finance. The May 2024 BOD and Financial Committee meeting will also include the first review of the Preliminary Budget for the 2023-2024 season.

This month of April closes out the payment cycle of the Annual Dues and Assessments and its 6-month payment plan. This balance was required to be fully paid by March 25th, 2024. Your April 1, 2024, billing statement will include renewal charges specific to your individual site for the 2024 season (Prox card renewals, boat and golf cart stickers, boat service, and pump-out plan requests), along with your quarterly electric assessment and state unit tax. Renewal information for each member was uploaded to the Dynamics member portal for review and approval by March 1st, 2024. Payment for these renewal charges will be invoiced on your April Member Statement and is due on April 25th, 2024. Special office hours for the pick-up of member stickers will be provided by the Administration.

An exciting feature of the new Dynamics platform for renewals is the development of Power BI reports, which assist Administration in targeting review and reconciliation of renewal analysis. This reporting has markedly improved the efficiency and optimization of the renewal process, minimizing discrepancies, and will instill greater confidence among members in the new system's procedures.



Safe Summer Guidelines

With the upcoming season, it's crucial to ensure everyone's safety. Here are some important rules to remember regarding cart safety:

- Persons must be properly seated and may not stand on the golf cart while it is in motion.
- Feet and legs should remain inside the golf cart while it is in motion.

- Passengers are not allowed to sit on the laps of drivers.
- Seating should not exceed the capacity designated by the golf cart manufacturer.
- Cell phone use while operating a golf cart is prohibited.
 - Just like on state roadways, cell phone use must be hands-free. Consider installing cellphone holders in your cart to keep your hands free for driving.
- The speed limit in the park for all modes of transportation is 10 mph.

Lake Monterey Reminders

As we enter boat season, please be aware that any use of the ballast function or modification to boats with the intention of creating waves for activities is strictly prohibited. **Wake surfing in any form is not permitted.**

As indicated in the proposed bid package schedule we plan to select a contractor to replace the 54" Corrugated pipe, complete the required work on the upstream embankment of the Dam, and install a toe drain on the downstream embankment of the Dam by May 9, 2024. We continue to monitor the water flow. At present no significant change is occurring. Should a change in water flow occur we will consult with the Engineer, the Drain Commission, and the Michigan Dam Safety Unit for a more urgent solution. The Dam Risk Reduction Grant awards will be announced on April 15th. Hopefully, our submission for grant funding is awarded to reduce costs.

CC#1 FEMA Storm Shelter Progress

The Michigan State Police Hazard Mitigation team has provided Salem Township with the documents to accept the FEMA Hazard Mitigation grant that would fund the Tornado safe room to replace CC#1 at Sandy Pines. The proposed Tornado Safe room would serve as a multipurpose facility. The safe room would be a shelter and would serve as a restroom facility, a cooling center, and a triage location in the event of a disaster. This facility will have a backup power generator that supplies power to the safe room as well as water well(s). We intend to power the water wells during power outages to provide water for 300 campsites during outages.

The Hazard Mitigation Grant is a 75% Federally funded and 25% Non-Federal recipient match. The Federal Share of the FEMA grant is \$917,332.28, Non-Federal share (Sandy Pines) is \$305,777.43 for a total of \$1,223,109.71.

The Federal and Non-Federal funds portion is for hardening costs or for design and materials that protect the occupants. Other expenses exist that are soft costs such as paint, flooring, roofing, toilets and urinals, and other items that are in addition to Federal Share and Non-Federal share. Funding soft costs can be as much or more than the non-federal share amount. Sandy Pines has anticipated replacing CC#1 and has planned to fund the replacement with funds set aside for this project. FEMA projects and Township projects have procurement policies, and the project will be eventually put out for bid by Salem Township.

Geese

If you live along the edge of the lake, it may be common for you to have some friendly visits from the local population of geese. It's great to see some wildlife and watch their interactions. The bad comes when they leave behind their droppings in your yard or on your patio for you to find later on the sole of your foot or shoe.

Sandy Pines has applied for a permit for egg and nest destruction. You can help by reporting nesting geese in your area by calling Sandy Pines Public Safety (616) 896-9006 and advising of the location of the geese and nest.

Once again, this year the State will not permit a roundup of geese. In the application for nest and egg destruction, the USDA Wildlife Services makes the following statements regarding geese roundups:

The last two years, the Canada Goose Round Up Program was cancelled because of the detection of High Pathogenic Avian Influenza (HPAI) H5N1 in wild birds in the state. Unfortunately, the disease has continued to persist in wild birds and mammals throughout the state and there continues to be cases in backyard poultry flocks. Avian influenza is a virus that can infect wild birds and both free-ranging and domestic poultry such as chickens, turkeys, quail, and geese.

With HPAI still present in the state, it presents a clear and important threat to wildlife and domestic poultry facilities. The DNR is cancelling the Canada Goose Round Up Program again for 2024 because of the risk of transporting HPAI around the state with the relocation of large numbers of Canada geese.

With the cancellation of Canada goose round up and relocation, the DNR is encouraging nest and egg destruction to resolve conflicts.

A goose can leave a half of a pound of excrement on your lawn. The excrement is commonly the most undesirable part of having geese on the lake. Human-use areas such as lawns, beaches, walkways, and shorelines can have excrement. These are the human/geese interface areas. Not the place that you can walk around barefooted. Goose feces near the water can be washed into the lake during times of heavy rains and degrade water quality.

So how do you reduce the number of visits to your lawn?

- Don't feed the geese. Feeding the geese will encourage the geese to return to your lawn and they really don't need your assistance. They are wild – don't make them reliant upon you.
- Put up two string fences around the perimeter of your lake front lawn. One string about 6" in height and a second about 18" in height.
- 3. The grape flavoring found in concord grapes (methyl anthranilate) is said to be a deterrent to geese. Repellants are found online or in homemade recipes with grape Kool-Aid. The spraying of your lawn with grape flavor concentrate may deter the geese. Methyl anthranilate in geese deterrent solutions can be expensive and cost over \$100/gallon.
- 4. The use of mylar balloons, cut-outs of predators, and even strobe lights are possible alternatives that can be purchased online.

- 5. Use a motion-activated sprinkler.
- 6. Use white swan decoys in front of your lakefront.
- 7. Use on-shore silhouettes of predator animals.
- 8. Use reflective pinwheels.

Geese are part of the natural environment. Some are residents and some are passersby. They are outdoors 24 hours a day. Most of us do not want to be the 24-hour-a-day deterrent. Their persistence in wanting to eat your lakefront grass will most likely win over your attempt to deter them. It's part of living on a lake and interacting with nature. A combination of deterrents is said to be more effective than just one solution.
