formation, or complete the online Renewal Survey at www.sandypines.com/annualrenewals. Included in your summary for your review is all boat information, including in/out service provided by Park & Garden; Boat Dock information/billing; Internet Service/billing; Bullpen info/billing (if annual); Mailbox info/billing; Pump Out Plan info/billing; number and billing for any mopeds or non-motorized boats.

License Plates Billed

Delayed production pushed the new license plate program into 2020-2021. While Members have until April 1, 2021 to get their license plates mounted to their golf carts, **the fee for the plates is being billed with 2020 Renewals**. In 2020 only, for each cart on file in Member Web Access, you will be billed \$7.00 per plate, or \$14.00 per cart (front and back

plates), maximum of 2 golf carts per site. You will also be billed the normal/annual sticker price of \$15.00 per cart. In 2021, the sticker changes from the 2"x3" sticker to a smaller current year plate sticker. Please make sure the number of golf carts listed for your site is correct, as this triggers the amount you are billed. While you have until April 1, 2021 to mount the plates, the 2020 sticker must be on your golf cart per the PSO's determined date. All of your license plate information and registration can be done online by logging into Member Web Access at www.sandypines.com/members.

FINANCE & ACCOUNTING UPDATE

Happy New Year and welcome to 2020! We have started this year off with great goals and focus going into the FY2020 season!

Introductions

First, I would like to welcome a great addition to our team, Jamie Bogema. Jamie is the new Human Resource Associate and will also fill in additional time assisting and planning events for the Recreation Department. She comes to us with great experience, knowledge and skills and we are so happy to welcome her to Sandy Pines.

Financial Review

An open Board meeting was held in conjunction with the Finance Committee to review the final FY2019 Financial Statements of the year. These reports are located on the Sandy Pines webpage www.sandypine.com/finance. Beene Garter was on-site early in January completing the annual review and tax filing for the September 2019 fiscal year. They will provide a report presentation and informational review to the Board of Directors and Finance Committee during the next meeting in March 2020.

September 2019 ended the fiscal year in a continued strong financial position for both SPWT and LMGC and in great preparation for

the specific finance and construction goals set for us in the months and years ahead.

SPWT Financial Review

In review of the FY2019 financial statements ending September 30, 2019 for Sandy Pines Wilderness Trails, we ended the year with a strong cash reserve and minimal debt. The current ratio for Sandy Pines is higher showing a good amount of current assets in relation to current liabilities and yet supports Sandy Pines not-for-profit goal of keeping 6+ months of cash on hand. The September 30, 2019 financials show a net loss of \$47k, which is a great position to end the year. It is a good reminder that Sandy Pines is a not-for profit organization with the purpose to fulfill the mission of Sandy Pines and maintain cost without making a profit, and minimize tax obligations.

The operational dues account for 45% of the operational expenses within the park. The remaining 55% of operational expenses are covered by the revenue received within the park activities and operations.

In reviewing the financial statements for Sandy Pines leading into FY2020, we will be meeting regularly as an Administration group and focusing on the strengths and areas of improvement for each department. For exam-

ple, most recently in the months of October and November 2019, we have noticed a significant increase in Refuse Expense for the park. There is a current inflation rate of 4% per year recognized on the cost of Refuse. Sandy Pines is recognizing significant amounts over this amount. FY2019 Refuse Expense was \$14k over the budget. Our Maintenance and Security department will be taking measures to monitor the use and ensure the park is not incurring extensive costs related to misuse of our refuse services.

LMGC Financial Review

In review of the FY2019 financial statements ending September 30, 2019 for Lake Monterey Golf Course, we ended the year with cash down approximately 35%, however the one Note Payable to Sandy Pines was paid off in the amount of \$75,000. Overall, LMGC Operations Cash was up 58% with current reserves for future projects, specifically the replacement well on the golf course.

Total Net Income equaled \$67k, which was approx. 10% lower than prior year. Weekend green fees were up 56% and power carts were 17% up from last year, with food sales 14% lower. Repair and Maintenance to the

Course was 19% lower than prior year and 38% lower than budget, with much focus on the fertilizing and seed on the golf course instead.

Looking ahead into FY2020, the early months of October and November 2019 do not show much activity in the off-season with the minimal expenses in line with budget.

Operational Dues and Account Balances

As mentioned in the previous Footprints and highlighted in the member e-news as well as on your monthly statements, if you are electing the option of the installment plan for Annual Dues and Assessments, your last monthly payment of the dues must be paid by March 25, 2020. The installment plan relates to your Annual Dues and Assessments only, and is not a payment option for any other charges to your member account. We have provided for your convenience on the statement a mini-

mum balance amount that must be met each month to be compliant within the terms of the payment plan and to avoid any risk of deactivation on your membership cards. In the future, please ensure if you are utilizing the payment plan that you are staying below the maximum balance shown on your statement. As of March 25, 2020 all dues and assessments must be paid in full.

Annual Renewal charges (per your individual member Automatic Renewal Summary sent the last week of January) will be posted on your March 2020 member statement and are due April 25th, 2020.

We would also like to remind you of the various payment options available to you:

- In office – Cash, Check or Credit Card payment (please note the Public Safety office is available to take payments 24/7 as well, in person only)

- Mail – Check payment
- Online Billing – Make a payment on your account using your MasterCard/Visa/Discover. Convenience fees for MasterCard/Visa/Discover Cards will be 3% of the total payment made. The new payment system will allow your payment to be reflective on your account immediately.
- Recurring ACH Authorization through your bank – Set a designated amount to pay every month through your personal bank that in time will create a credit balance close enough to cover your dues and assessments prior the new season.

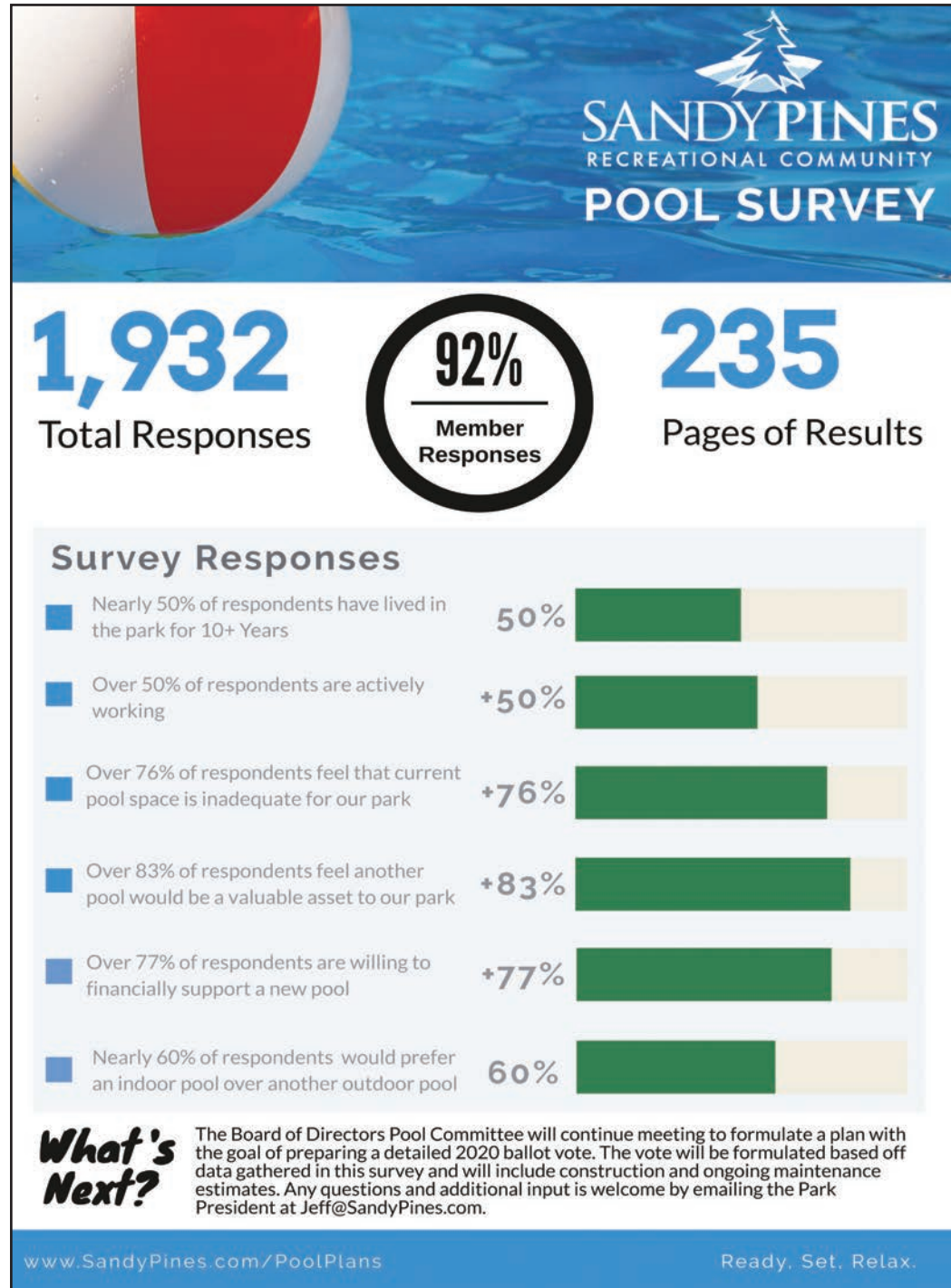
First of all, we would like to say thanks for your overwhelming participation in our recent pool survey. Your responses provided needed input to get started with this project in a way that can address your concerns and needs. Beyond the information gathered about increasing pool capacity, your comments gave us insight on many issues. We read your comments with great interest.

The committee met on December 10 to review the information gathered from the survey and talk about the next steps in the process. The Pool Survey Infographic shows a summary in regards to support for the project and willingness to support the project financially.

The committee discussed several issues including the requirements for lifeguards, jobs opportunities for lifeguards, insurance liability, as well as the time periods during the year that an indoor pool might be used. At this time a risk assessment study has ensued to look at these issues, as well as possible Michigan state regulations that could apply. Once this study has been completed the committee can begin fine tuning a proposal for consideration that is based on the results of the survey and the risk assessment results. That proposal will include concept drawings.

March and will be on your April statement along with your quarterly unit tax and quarterly electric. Payment in full is due April 25th. The deadline for updating your renewal information is March 16th. Member cards cannot be canceled for credit after the March 16th deadline. Purchasing new Member cards is not related to renewals; new cards or replacement cards require a photo and can be purchased in person at the Main Gate Public Safety Office. For questions regarding Member cards, please contact the Public Safety Office directly at 616-896-9006.

Stickers are automatically mailed with your April statement to the current primary address listed in your Member Web Access Portal, unless you request we hold them at the Main Gate. **Once stickers are mailed they become your responsibility and we must charge the full price for their replacement.** If you find lost stickers or they finally catch up to your change of address, the deadline for crediting returned stickers is July 1st. If your boat registration expires prior to April 1st, your water sticker is not included with your April statement, however you are charged for the sticker. Once we receive your updated boat registration we can provide your sticker. If for any reason you don't receive your April statement and stickers, log into [Member Web Access](#) and verify your mailing address; contact Member Service at least 10 days before the bill due date of April 25th. Renewal Stickers

include Water, Land, Non-motorized boats, Golf Carts, and Mopeds. Bullpen and Handicap stickers are permanent and are not replaced with Renewals. Blue Tank (waste tote) stickers are annual and can be purchased at Member Service or at Public Safety.

Boat Stakes & Docks Update

Thanks to the Park Inspector, available stakes have been identified and those deemed not useable labeled as such. In 2019, through sales, assignments, relinquishments and declinations, 104 Members came off the stake and dock waiting lists. We will be working as quickly as possible to make assignments on the remaining available stakes. For most, these will not be ideal positions; those who truly want a boat stake may have to park and walk a fair distance to access the stake. Keep in mind, only one person from your party has to go get the boat. They can bring the boat to a temporary accessible point for family and friends to load/unload, such as the handicap dock by the dam, or an accessible point near one of the beach areas. For

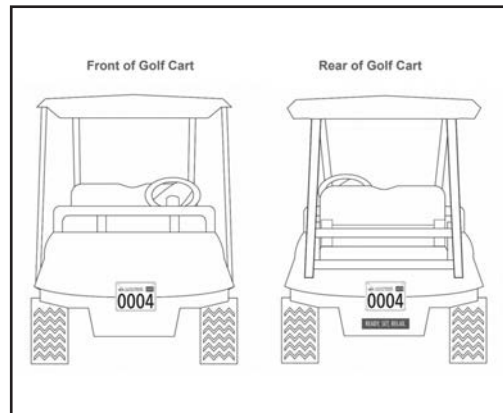
If you do not have a computer to register on line stop at the Public Safety Office to pick up a paper form or use Kiosk at the Member Service lobby or Public Safety Office.

Two sets of license plates consisting of a front and rear license plate are available for each membership site. If you have two golf carts then you will register both golf carts online or in person with a paper form and pick up the license plates from the Public Safety Office. If you have one golf cart you will register the golf cart online or in person with a paper form and pick up the license plates from the Public Safety Office.

Please review your renewal form for the proper number of golf carts on your membership. The renewal form will include the number of golf carts that you registered last year and your membership will be billed for license plates based on the number of golf carts you have registered to your membership.

If you have one golf cart and add an additional golf cart your account will be billed for the second golf cart license plate at the time of purchase.

Member/owners of golf carts are required to register and pick up license plates for golf carts. Please bring your golf cart to the Public Safety Office when you pick up your license plates. Public Safety Officers will affix a serial number on the steering column of the golf cart at the time of license plate issuance.



License Plate Installation & Positioning

A golf cart plate issued for a golf cart shall be attached to the center rear, and center front of the golf cart.

Minimum distance of the bottom of the License Plate must be no closer to the ground than the Golf Cart Floorboard to the ground. Maximum distance of the top of the License Plate must be no higher than eight inches from the bottom edge of the Golf Cart Windshield.

A golf cart plate shall always be securely fastened in a horizontal position to the golf cart for which the plate is issued to prevent the plate from swinging. The plate shall be attached front center of the bumper, in a place and position that is clearly visible. The plate shall be maintained free from foreign materials that obscure or partially obscure the registration sticker and in a clearly legible condition. The attachment of the plate to the rear of a golf cart, in a place and position that is clearly visible and not obstructed by a tow ball, removable hitch,

or any other device designed to carry an object on the rear of a golf cart, including the object being carried.

The training consists of 72 hours, and covers topics of EMS Systems, Workforce Safety and Wellness, Professional CPR/AED, Medical, Legal and Ethical Issues, Documentation, and Communications, The Human Body, Airway Management, Lifting and Moving Patients, Patient Assessment, Medical Emergencies, Bleeding, Shock and Soft Tissue Injuries, Poisoning and Substance Abuse, Behavioral Emergencies, Environmental Emergencies, Child Birth, Pediatric Emergencies, Injuries to Muscles and Bones, Geriatric Emergencies, Transport Operations, Vehicle Extrication and Special Rescue and Incident Management.

The training included workshops with practical and written examinations. Employees who completed the training will take a final National Registry examination this month and will then be licensed. Responding to medical emergencies comprises a substantial portion of Security Services call volume, and staff are committed to continuing education and licensure endeavors. COMMUNITY CPR TRAINING

Cardiac Pulmonary Resuscitation (CPR) & Automated External Defibrillator (AED) classes will be provided on June 17th, July 15th and August 19th at the Pavilion for members of the Park. All classes will start at 10:00am and last up to four hours. The CPR classes will be for adult, child and infant. The CPR classes are free as a non-certification course. If you need certification the cost is \$35.

The importance of knowing CPR is important and acting immediately has the ability to increase survival rates of a cardiac arrest vic-

tim. If you wait for first responders to arrive on scene to perform CPR the victim has less chance of being resuscitated. Most positive outcomes of CPR are a result of community involvement, first responders and advanced life support EMS all playing a part in a better outcome.

If you have not taken a course before or just need to have a refresher please consider taking the time to participate. In most cases it is a family member or friend that is the victim of cardiac arrest. Your knowledge at the time of the event can help save their life.

LAKE MONTEREY GOLF COURSE NEWS

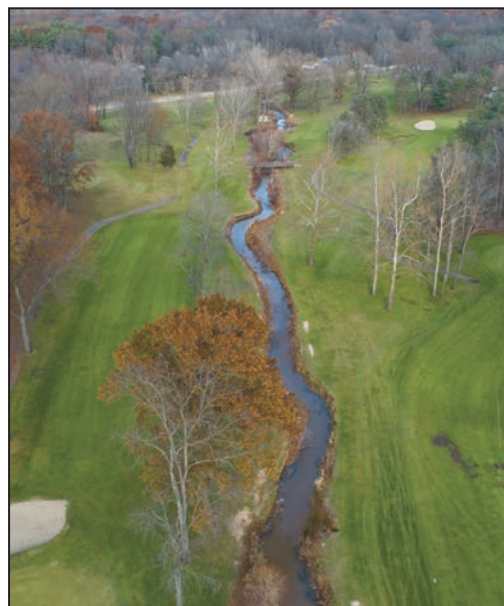

Happy New Year and welcome 2020! We've had an unseasonably warm winter and so much so that we even had golfers out on the links on Christmas Day. You're welcome to use the course in the off season but please make sure the turf isn't soggy and that you're not damaging the course. While the Pro Shop is closed, we do have a collection box at the start of the course for green fees. We appreciate your donations as they help with off season maintenance of the course.

All of our annual golf outings and events are listed on the new 2020 Sandy Pines Wall Calendars. We're also looking ahead to 2021 and coming up with some new events to celebrate our park's 50th Anniversary, so stay tuned for details as they unfold. Here's the schedule for the 2020 season:

We continue working on tree removal and course improvements as weather permits. I have been fielding recent member inquiries about which trees are being removed and why they're being removed. There are three main reasons why we remove trees from the course. The first is safety. If a tree is carrying



disease, dead or dying, we remove it as it is unsafe. The second is how it impacts the turf. Too many trees in one area may provide too much shade which may prohibit healthy turf conditions. Last is improving course playability, which can increase the speed of play and make the course more enjoyable.

We have thinned out the woods between Hole 1 and Hole 9, removed six scotch pines at the top of the hill, thinned out the tree on the Hole 4 tee box, and removed all the scotch pines roughly 150 yards out on Hole 3 near the big oak trees just past the power line. We'll be working on more tree removal and thinning out the tee box on Hole 8. We'll also be working on the back nine to remove a few trees that are diseased and unsafe.

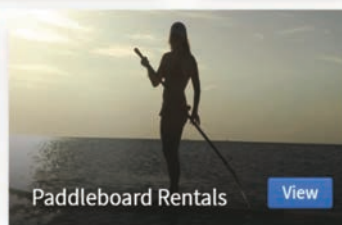
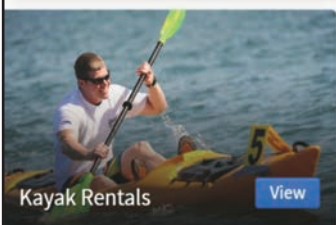

Winter is always one of our busiest times of the season as we're busy maintaining all the buildings, structures, and amenities that are utilized by members, guests, and campers all summer long. One of our largest off season projects for the past few years has been updating water risers in each phase. Many of the old risers are in rough shape and can be very difficult and time consuming to replace, especially if they have been invaded by roots. Although it may be enticing to plant shrubbery near your water riser and/or your electrical boxes to mask them we do not recommend doing so as it can lead to long term difficulties. We have completed almost all of the water risers in Phase 4. The sites west of the tennis courts are not yet completed.

NORTH SHORE CENTER UPDATE

We continue to work with FEMA, The State of Michigan Hazard Mitigation Team, Salem Township and the Storm Shelter Committee to build the North Shore Center.

In January the construction company will be installing helical piles. Based on the engineers report these Helical piles are needed to support the weight of the building. The previous building at this location had foundation issues. Most likely because the soils below did not support the previous foundation. These helical piles are engineered and tied into the foundation of the building. Once the helical piles are installed the building foundation will be started.

The walls of this building will be precast concrete which has been designed in cooperation with the construction company, the Architect and precast concrete company. The building is a dual purpose facility to function as a FEMA P-361 compliant storm shelter as well as an activity center with meeting rooms, a library and an all-purpose room for events.

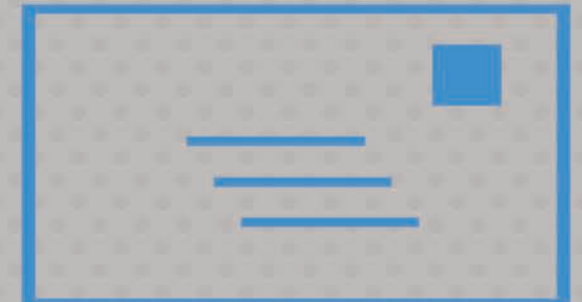
