# LETTER FROM THE CHAIRMAN OF THE BOARD

Winter hung on until the middle of April this year. Many were wondering if it was ever going to end. At the time of this writing it was mid-April with a temperature of 30 and snowing like it was the dead of winter. As I was looking out the window the Crocuses were waving in the wind as if to say that spring was just around the corner. Just like they said, here it is. And so, it is time to resupply our units and begin to think about clean-up. The staff has been working hard to get the park ready for us. Many improvements have been accomplished, which you will learn about as you read further in this Footprints.

Some of the committees have begun to consider agenda items for the coming year. In early April, for example, the Policy Committee received a

draft copy of a comprehensive policy manual. They will have studied and reviewed the policy in anticipation of presenting it to the Board of Directors sometime in May. The Board will take a few weeks to read and become familiar with it, and hopefully adopt the policy at its regular June meeting.

Sandy Pines has never had a unified policy manual. Over the years, several individual documents were approved and served the purpose of policy. During the winter months, Sandy Pines' Executive Administrative Assistant compiled all the individual documents, which were then used to create a proposed policy manual. If you had the opportunity to read my April article and took the park tour to see the changes that have occurred in the off-season, I am hopeful that you enjoy what you see. I would encourage you to thank our staff in the Maintenance Department for their efforts in accomplishing much of the work that was done.

Sandy Pines would not exist without those who faithfully volunteer in so many ways here in the park each year. We are grateful and indebted to all of those who serve as grounds workers, Board Directors, committee members and caretakers, just to name a few. Today I would like to send a thank you to the Library Team for their recent undertaking.

One major move and renovation that took place in the last few months was the move of the library from the Admin. building to the Retail Center. We would like to thank the following Members who made that move happen: Lynn & Paul Bailey, Ebby King, Carolyn Camenga, Bea & Jerry DeWeerd, Lisa Britten, Norene Squint, and Jan Raak. A big THANK YOU goes out to this Library Team for the time and energy they took to organize and accomplish this move!!! We truly appreciate

your assistance in the move and wish you well as you continue Library care, programming and management. Be sure to check out the new Library section on the Sandy Pines website!!

The 2016 FEMA construction project of CC 5 & 6 that began in September 2017, was completed on April 13, 2018, followed by a FEMA closeout meeting held on April 19. This major project went very well, with all expectations of scheduling, timeline goals, quality and budget being met or exceeded.

Additionally; late last summer I was approached by Salem Township to inquire if Sandy Pines would be interested in submitting another project. In September, I brought the opportunity to the Board of Directors to get a consensus for their level of interest. The interest was very positive, so we put the same team of people on the new application. Steve Deyarmond, our Emergency Services Director; Jim Pitsch, the Salem Township Supervisor; WLP Engineering, and Scott Corbin, Director of Allegan County Emergency Services.

A preliminary plan for a two-story structure was developed with the intent of placing this new facility in the same area as the previous Indoor Pool/Adult Recreation Building. The floor plan drawn would have the capability to hold approximately 1100 persons in a severe weather situation. The structure would provide space for

## NEWS FROM THE CONDOS

The very busy building season continues at the condos. As reported in the April Footprints, since October of last year, six new condos have been built and occupied with another two-unit building under construction. As that new unit is moving toward completion with one of the units already reserved, a new two unit building was started in early April, with one of those units already under contract! This leaves only one more building to start to complete the condo project.

When the final units are sold, they will have added 54 dues paying memberships to the Sandy Pines Association. Because these are permanent year round residents under a different Charter, these are in addition to the number of sites allowed to the park as a campground.

The condo residents are getting ready to participate in our 3rd Annual Bridge Walk on June 7th. Residents will meet at the condo entrance nearest the Public Safety Office and proceed to walk through the condo development, snacking on items provided by residents. There will be a toll collected at the bridge in order to cross, with the money to be part of a drawing during the potluck cookout that follows the end of the walk in Phase 2. This has always been a fun event, now even better, with more residents to participate.

Our potlucks will resume in May, and our monthly Women's Breakfasts continue to build friendships. All of these activities, in addition to all the park has to offer, make this such a great place to live.

small meeting rooms, as well as a larger space to hold individuals for a larger indoor event.

Additionally, the plan allows for access to the building from both levels, with one being from the beach area. Although the plan is not set in stone, there is a preliminary floor plan made for the purpose compliance within the FEMA application. Final plans will not be completed until we know whether or not the grant is approved.

A bit of good news occurred on March 29, when we received notice that our application had been approved to be sent to the next level of consideration. At this level the P361 compliance (Storm Shelter) specifications will be reviewed prior to approval, or denial, of the grant. We are awaiting a final decision on this project which is currently estimated at \$3.8 million.

If approved, FEMA will again provide 75% of the funding that applies to the P361 requirements. This is significant because our Team has taken what was learned on the previous FEMA project and used it to increase the percentage of FEMA compliance aspects within the entire project, in an attempt to minimize the cost to Sandy Pines and maximize the available funding from FEMA. Stay tuned to our website and eNews for any other details as they become available.

In other areas of the park administration, the Public Safety Department, now consisting of the Emergency Services and Security Departments, is coming along very well. Keith Garvelink (Interim Director of Security) has done a great job of

finding, hiring and filling vacated positions with Public Safety Officers (PSO's) many of which have experience in law enforcement, medical and/or fire services. These new hires will be great additions to those PSO's that you will find familiar from past seasons. Please stop PSO's or stop in to the Public Safety Building and get to know them!

One item of business: I have been asked to mention that our Member Services department has had a number of calls, emails and conversations with Associate Members attempting to transact business for a Member's site. The reminder is that our operational policy states that our Sandy Pines Staff may only conduct business with the Member(s) of record. There are exceptions where legal documentation has been provided naming an Associate as the legal designee, Executor or Guardian. In cases where there is a divorce situation, a court order must be provided for the membership to change from a Co-member to a Member. In situations where the Member is no longer active in managing the membership, we suggest transferring the membership. Our office will not conduct business with an Associate Member under conditions other than those listed above.

As you enter the park you will notice the renovated entrance signs that were completed this past winter. This was done as part of the branding of Sandy Pines and to be in compliance with the new logo. If the sign looks familiar, it's because they were refabricated rather than replaced.

Put on your Calendar: Memorial Day falls on May 28 this year, so please plan to attend the Memorial Day Observance that will be held at the Veteran's Memorial area across from the Recreation Station. Look for details on the website or in other places in this issue of the Footprints.

Also, put May 19th on your calendar and plan to attend the first Face to Phase meeting at the Pavilion. The time will be from 9 to 11 am. There will be Coffee, cookies, water and a chance to enter a drawing to win prizes. These meetings were created as a place where Members can come and share ideas, ask questions, make comments, or simply listen to learn! There are generally Staff members there, as well as a Board Director(s) who join me at these meetings. We look forward to seeing you!

If you are interested in getting a reservation for a golf cart you can email the information and we will send you a confirmation for the dates you request. Be sure to include the date you wish to pick up and to return; time for pick-up (during store hours); type of cart (4 or 6 passenger); Site number; phone number and email address. You can also call 616-896-9334 and leave a voice mail. The new Rental Office number is not connected as of this date, so please call the Park and Garden store number. Remember that the holiday weekends and garage sale days are very busy so be sure to order your carts early. We have a 24 hour cancellation period, so if you need to cancel a cart order, you can do so 24 hours before the rental time with no expense. If you don't cancel until the day of the rental there is a one day rental charge.

We have switched to a daily rate for the carts this year and have lowered the charges for the 4 passenger to \$50 a day. Regardless of the pick up time, the cart is always due back to the store by 10 am in the morning. You can also reserve the golf carts online by going to the Sandy Pines Website and clicking on the button for reservations.

The **Rental office** has moved to its new location on the end of the Retail Center building. We will have small tools available for rent this year and will be adding more, as the need arises. The Rental Center hours are Monday–Thursday and Saturday from 9 am to 4 pm; Friday from 9 am to

7 pm; and Sunday from 10 am to 4 pm.

For those wanting to pick up a water softener for self-install, we will be at the store on Tuesday, Thursday and Friday from Noon to 1 pm and again from 5 to 6 pm. Saturday will be by appointment only. Deliveries of bulk products can be made Monday, Tuesday, Friday and Saturday.

Store hours this year will be full time beginning Memorial Day Weekend. We will be open from 9 am to 4 pm Monday through Saturday. We will be open on May 18th and 19th from 9 am to 4 pm. Sunday hours will begin on June 3rd and will be from Noon to 4 pm.

We are currently stocking the shelves for the season and we have several new products this year. Stop by the store and see what we have available for you. If you don't find it on our shelves let us know what you need, and we will attempt to stock it.

We have secured a new supplier for our 3 and 5 gallon bulk water this year and have been able to lower our price to \$4 for the 3 gallon and \$5 for the 5 gallon water jugs. We also have water coolers available for purchase.

Remember that even though we might be a little more expensive than the large stores outside the park – The Park and Garden profit goes to help Sandy Pines. We are here to serve you.

# EMERGENCY SERVICES DEPARTMENT NEWS

## Preparing for the summer and medical emergencies:

Please take the time to review and/or prepare a list of your medications, allergies and medical conditions. Place this list in your medicine cabinet in your bathroom. In the event that you or one of your family members become ill, the information will be available to first responders and local hospitals, if transported to the hospital. Please discuss your preference of the health care facility that you or your family prefer to use in the event of an illness or injury.

West Michigan has several hospitals in the area. Hospitals are commonly rated as a level one, two or three facility, based on their staffing and ability to manage illnesses and injuries. Hospitals also have accreditations to

be designated as a Trauma center, Stroke center or Heart center.

**Local Trauma Centers** for injuries are Metro Health Hospital (level 2), Mercy Health Hospital (St. Mary's-level 2), Butterworth Spectrum Hospital (level 1).

**Stroke Centers** are Metro Health, St Mary's and Butterworth Spectrum hospitals. In the event of a stroke you should choose a hospital that has the ability to use invasive means to reduce the effects by providing a clot buster, performing a thrombectomy, or stopping bleeds in the brain.

**Heart Centers** are Metro Health, St Mary's and Butterworth Spectrum. In the event of a heart attack/chest pain or pressure, you should

discuss with your family your choice of hospital. Metro Hospital, St Mary's and Butterworth Spectrum hospitals are designated facilities that can provide care.

Discuss your health conditions with your family and your choice of a health care facility. Prepare by listing medications and health conditions. Call 911 when you have health emergencies. Don't wait to call 911. Commonly, people wait too long to call for assistance for chest pain or breathing problems and they also fail to recognize the signs of a stroke. Stroke symptoms include facial droop, slurred speech, or the inability to hold arms out in front of them. People often deny chest pain, pressure or tightness.

# PUBLIC SAFETY OFFICE NEWS

## GUEST PASSES

As we have numerous new members each year, it is timely to post information for members on how to obtain a guest pass. Members can do this from their own device or may use one of the kiosks at the South Station. Members will first go to the Sandy Pines website and log into their account. If the member has forgotten their log in information, we can retrieve that information and provide it to you. The member will be asked to agree to the rules regarding guests upon signing in. From here, the member will go to Guest Sign in and will need to enter the first and last name or names of the guest(s). The member will be asked for the date of the visit. After completing this, select the "print to Ranger Station" option and log out. This will generate the vehicle pass which will be placed on the guests' vehicle upon arrival. The guest will also need to have a daily vehicle sticker applied at the same time. The cost for a guest permit, if done by a member, is \$4. Our staff can also perform this service for the member at a cost of \$6. If members have any problems generating a guest pass we are happy to assist either at the station or by phone. The phone number to the South Station is 616.896.9006.

## CPR CLASSES

Public Safety Office will offer a CPR class to members if there is sufficient interest in completing this class. We would need six people, minimum, to

## BRINGING TRASH INTO THE PARK

Please remember that park rules prohibit members from bringing trash items into the park for disposal from any location other than the members' site. Members who do this may incur a \$100 fine or be charged the cost of removing or disposing of any items from outside the park. There have been recent instances of large amounts of trash being brought into the park from outside. This costs the park, and ultimately you, money. Please refrain from doing this.

## BURGLARIES IN PHASE TWO

Regrettably, we have had several burglaries occur recently in Phase two of the park. These crimes occurred in the early morning hours, and involve two male suspects who appear to have been on foot. Property stolen consists of mainly electronic items such as televisions. There is an ongoing investigation into these crimes by the Safety Office and Michigan State Police. I have been asked by several members if there are any steps members can take to prevent crimes such as

this. One thing is to be observant and report any suspicious persons or vehicles to the Safety Office. We are here to respond to calls such as this and welcome any information regarding suspicious activity or persons. The Safety Office has already received calls from residents reporting this type of such activity. I would like to thank those individuals who contacted us and I encourage all members to promptly report any suspicious activity to the Public Safety Office at 616.896.9006. Members should take a few minutes to record information with regard to their valuables. A record of the price of purchase, item description, and a serial number is invaluable if a crime occurs. This information allows law enforcement to enter the stolen item into a nationwide database and also makes it much easier for the victim to report such instances to their insurance companies. Taking a photo inventory of valuables, including pictures of any identifying numbers, can also make the process of tracking property and reporting a crime, much easier.

### FEMA GRANT PROJECT UPDATE:

The construction of the two new FEMA approved storm shelters in Phase 3 is nearing completion as they have already been approved for occupancy. Over the next month we will be working with the local governments, State of Michigan and FEMA, as we close out the project. # EMERGENCY SERVICES WEATHER INFORMATION

## Sandy Pines Severe Weather/Tornado Shelters Phase 3:

The intended purpose of the Severe Weather/Tornado Safe Rooms in Phase three is to provide near-absolute protection for Sandy Pines residents, their visitors, and staff, within accessible distance during a tornado watch, tornado warning or other short-term extreme wind hazard events. The shelters are intended for the population of Phase 3 and are within five minutes walking distance or half mile driving distance. The shelters were built to shelter the average daily population of Phase 3.

The Safe Room is equipped to provide only the most basic short-term essentials. The shelter is not intended, and was not designed, for long term sheltering. Common time for sheltering for a tornado in the State of Michigan is two hours or less.

The Safe Room has been engineered, designed and constructed in compliance with the design and construction criteria for community safe rooms as defined by FEMA P-361.

**Safe Room Building Design Wind Speed:** Zone IV, 250 mph, 3-second gust (tornado)

**Missile Impact Design Speed:** 15-lb 2x4 @ 100 mph (vertical surfaces), 15-lb 2x4 @ 67 mph (horizontal surfaces)

**Maximum Design Occupancy of Storm Shelters in Phase 3:** 260 people/building CC # 5 and 210 people/building CC # 6

**Near-Absolute Protection** Based on current knowledge of tornadoes, the occupants of a Safe Room built according to the guidance in FEMA P-361 will have a very high probability of being protected from injury or death. Other Convenience Centers in the Park are thought to be a better alternative to sheltering in an RV, tent or camping unit.

## ALERTS AND ACTIVATION: Activation of Outdoor Warning Sirens:

When a National Weather Service Tornado Warning is issued for Allegan County, Allegan County 911 Dispatch or Allegan County Emergency Management, will activate the Outdoor Weather Sirens located in Phase 1, Phase 3, and Phase 6, for potential weather threats near Sandy Pines.

Siren activation is based on Allegan County 911 Central Dispatch and Allegan County Emergency Management policies and procedures. Upon activation of Weather Alert Sirens, residents should immediately move to their place of shelter.

### RAVE system Severe Weather Notification:

The RAVE Alert system uses IPAWS, which will automatically forward National Weather Service Severe Weather and Tornado Warnings to registered staff and member cell phones, in the form of text and emails advising, of a threat. Please contact Member Service if you are not receiving Rave Alerts.

### Persons should seek shelter when observations or other forms of media indicate a severe weather threat.

Storms can develop within our area rapidly before alerts are activated by NWS, media or local emergency. Be vigilant in your observations and seek shelter when you observe, or think that a threat to your safety exists.

The **warning sirens** are located in Phase 1, Phase 6 and at the Sandy Pines Phase 3 Camparound Entrance. Outdoor warning sirens

### Public Warning and Notification System

Salem Township has installed a outdoor warning device in Sandy Pines for your protection, this siren located in Phase 1 in the Core Area



#### TESTING Procedures:

4<sup>th</sup> Friday of each month at 11:00am,  
You should take this time to review your emergency response plans.

#### EMERGENCY Activation Procedures:

When the siren activates you will hear a (3) minute "steady" tone. At this time you should seek shelter inside a basement or sturdy structure and tune to local radio and television for further instructions.

are activated and operated by Allegan County Emergency Management and Allegan County 911 Central Dispatch. Allegan County Emergency Management or 911 can activate the warning based on weather information in accordance with procedures established by Allegan County Emergency Management and Allegan Central Dispatch.

Members, guests, residents and staff are responsible for monitoring severe weather conditions, alerts, and warnings, and to monitor/observe changing weather events. Persons should seek immediate shelter prior to weather siren activation when a severe weather event is observed or a warning is indicated by other sources, such as, but not limited to, local television, radio or RAVE phone alerts.

Regardless of activation of a weather siren, television or radio alerts, members, guests, residents and staff should seek shelter upon observation of severe or changing weather conditions that may be, or have the potential, to cause injury or be life threatening.

Please take the time to discuss your family plan of action for severe weather, and your planned place of shelter. Please discuss who you should contact and have their contact information available in the event of an emergency.

Sandy Pines will NOT perform door to door warnings for residents.

There will **not** be an Outdoor Warning Siren activation issued for an "All Clear". Rather, all National Weather Service Watches and Warnings have an expiration time, after which the severe weather conditions are no longer a concern. Our Public Safety Department staff will notify each facility in person, or by RAVE, of an expiration of a severe weather warning event.

### PARK OPERATIONS:

Park operations during a Tornado Warning will be

focused upon the safety of individuals in the Park. Park business operations will be closed during severe weather or tornado warnings and everyone will be advised to take immediate shelter.

## Parking

Parking at or near the community Safe Room facility is limited. Those seeking shelter are encouraged to walk. This will allow disabled individuals to use the paved parking and accessible walks. Please use caution and watch for pedestrians when traveling to the shelter by vehicle.

### Safe Room Rules

1. No smoking
2. No drugs or alcohol
3. No weapons
4. If you must bring a pet, it **must be confined within a carrier** and placed in designated pet area within Safe Room. Clean up and control of pets is the responsibility of the **pet owner**
5. Follow instruction of Safety Team members
6. Report any issues or injuries to the Safety Team
7. Supervise children closely and keep them nearby
8. Keep noise to a minimum so weather updates and instructions can be heard
9. Cell phone use permitted. Potential exists for an overload of the cell phone system during emergencies. Texting may work when phones fail.
10. Earphones must be used on **all** music and entertainment devices
11. Be courteous, maintain a calm and orderly atmosphere
12. Go inside the shelter upon arrival at the shelter.

**Dial 911 for emergency situations** – Provide phase location and building number.

Residents are encouraged to use the Severe Thunderstorm Watch and Tornado Watch information to anticipate the development of severe weather. Time should be allotted for residents to gather essential items and travel to the shelter in an orderly fashion. Parking is very limited and walking is preferred.

### What to bring to the Safe Room:

Medications needed or medical equipment

- Personal care items
- Baby items
- Appropriate clothing for weather conditions
- Cell phones
- Appropriate pet care items (carrier, waste bags, food)
- Portable NOAA Weather Radio

### What NOT to bring to the Safe Room:

- No Drugs or alcohol
- No weapons of any kind
- No large items that take up space needed for people

Do NOT bring your car if you can safely walk to the building. If you must drive use your golf cart if weather permits.

When the Outdoor Weather warning siren activates please take immediate shelter. **Do not call Security or 911 to ask what the Siren is for.** Take immediate shelter.

After Severe weather many injuries occur as a result of debris, electrical wires, trees or branches. Please use caution after the event and watch over children when leaving the shelter.

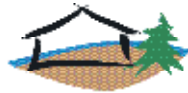
