LETTER FROM THE CHAIRMAN OF THE BOARD

A new season is about to begin at Sandy Pines. Soon the warm temperatures will be here and it will be time to get outside and enjoy all the activity that comes with it.

The staff has been very busy during the off season sprucing up, fixing, renovating, cleaning and getting the park ready for our return. The two new restrooms in Phase 3 will be ready for use upon your return. The construction process went well and pretty much stayed on schedule. As you may remember, most of the funding for the two buildings came from FEMA. These facilities serve

a dual purpose which is a safe place for shelter during storms, and of course, as restrooms.

As you know, during the off season the Board of Directors do not meet, but that does not mean that on occasion, decisions need to be made during this time period. Board members vote by phone or email to make a decision so things are not unnecessarily delayed. The Board did this twice in the last three years, once in 2015, to approve the operating budget for the Golf Course and again in 2017, to approve a rule change for site clean-up. The Board will then pass a formal Resolution at their first scheduled BOD meeting at Sandy Pines, affirming the action taken during the off season. The Board followed this same procedure during this off season. You may recall that at the September 2017 meeting, the Board approved a Resolution for Sandy Pines to create a line of credit of 2.5 million with our bank,



United Bank. The purpose of a line of credit is to cover Sandy Pines financial needs for major capital expenditures, should it exceed the annual amount of revenue received from our 10-year approved Capital Reserve Fund. After United Bank proposed a line of credit, they withdrew the offer based upon their legal counsel. United Bank was now requesting a vote by the membership of Sandy Pines. However, Sandy Pines' legal counsel advised that under our bylaws, the Board of Directors had the authority to engage in a line of credit. Therefore, Sandy Pines administration approached West Michigan Community Bank concerning a line of credit which they were happy to do. Their legal counsel encouraged them to engage in a financial relationship with Sandy Pines and to provide a line of credit. Therefore, the off-season vote was to re-affirm the

September decision, but to do it with a different bank. Now, West Michigan Community Bank, will become Sandy Pines bank for handling all our funds. To make this change will be extra work for staff. To hold off on this decision until this spring/summer, would create a hardship for our staff when they are very busy with the return of members.

Sandy Pines is a great place to be. It serves many purposes for our members. It promotes good health, we gain new friendships, we engage in physical activity, provides relaxation, we can enjoy art and culture, provides learning experiences for children...and it benefits the economic health of the community at large. Whatever your purpose may be, come and enjoy the 2018 season.



LETTER FROM THE PRESIDENT

Sandy Pines will soon awaken with the arrival of many Members that are anxious to come back to this special place that has an ability

to bring so much joy to so many lives. On behalf of your staff here at the Pines, we welcome you back and invite you to take a look around the park to see some of the positive changes that have occurred over the winter months.

In Phase 3, you will see two new Convenience Centers that were constructed over the off-season and it is our expectations that these new facilities will provide decades of use for the folks in that phase, as well as provide a high level of safety in the event of severe weather.

As you may recall, Sandy Pines applied for, and received, an \$857,000.00 grant, used in part for a new weather warning siren by the Chapel area in Phase 6, with the bulk of FEMA funds designated to the \$2,100,000.00 construction projects in Phase 3.

We are grateful that the remaining funding needed for these two projects was paid for with cash reserves, while retaining our 180 day operational reserves. Having the ability to do this confirms that it pays to watch closely where and how money is spent, but also it reminds us to pay attention when opportunity knocks for the potential of outside revenue. When it presents itself, we need to follow it to see where it goes.

We have long been told that Sandy Pines would never be eligible for a grant like this, but nevertheless we had a number of knowledgeable and talented staff, township, county and state Officials that persisted and persevered to make the FEMA grant not only possible, but a reality.

As you travel around the park to look the place over, you will go past the soccer field area and notice that a number of unhealthy trees and scrub has been removed that were on the property line between Sandy Pines and the Weber farm. Also we installed a new 6' chain link fence on

that property line to mitigate an issue with golf carts going on to the Weber farm property and damaging their crops. In order to be a good neighbor after having a conversation with Mr. Weber, it was in our best interests to put up the fence.

If you continue your trip around the park, you will notice that CC 11 is having, (or hopefully by the time you return) had a facelift at the entrance. This was done to open up the area of the concrete foundation walls and remove the dirt and stone, providing a greater exposure of the building face and limiting the potential for Climbers to gain access to the roof area. Also, unseen inside the CC there were a number of repairs and improvements made to the plumbing lines etc.

Continuing on your tour, stop by the Public Safety Office Building (formerly known as the Ranger Station). Stop in and meet Keith Garvelink our Interim Security Director and his staff. Keith's office is in the same room as where the Inspector was located previously. We welcome Keith to this position, as well as welcoming Steve Deyarmond to his new position of Emergency Services Director. Steve's office is also in the PSO building located in the northwest corner. These two men will be working together with the Security Staff to make Sandy Pines a safe and secure environment for our families and friends.

As you continue on your trip around the park you will make your way over to the Retail Center.

There you will want to stop in and see the new library, now located in the northwest corner of that building. Also newly located in that building are the Inspector's office, and the relocated Just Your Style hair salon.

The Rental department and Park and Garden will also be moving into the Retail Center as time and budget allow, but the expectation is that Rental will move in this season and Park and Garden will be moved in for the 2019 season.

Subsequent to the time that Park and Garden moves into the Retail building, the current Park and Garden building will be used to house maintenance equipment that is currently stored outside. Additionally, we are considering the addition of a 20' lean to, that could provide space for (11) 10'x20' storage units for rent.

When you are traveling around to see all the changes, you'll notice that the park and garden landscape material bins and LP Gas station have been removed and room made for additional parking in that area. The material bins, and greenhouse are now located between the Park and Garden building and the Retail building, just west of the opening driveway. The LP Gas station is located near the trash compactor north of the Retail Building.

Another change that took place during the off season is that the former library has been turned into a Conference/Meeting Room. Basically, we took out the bookcases and painted the walls to clean up the space, as well as relocated the

conference TV screen and Whiteboard from the old conference room. The previous conference room is now the office of our CFO. This renovated area now provides sufficient space for her needs, while also providing an ability to have a meeting table in her office for private meetings with Staff related to HR. (Human Resources)

As you look at the many physical changes, please understand that they have been largely accomplished by the gifted and talented staff we have working here at Sandy Pines. Carpentry, drywalling, painting, plumbing, concrete work... just to name a few trades we have on staff. I have been amazed to watch these men and women using their gifts to make Sandy Pines a better place. Please encourage them when you meet them or have conversation with them. We are Blessed to have them.

I'd like to finish by stating that our Maintenance department is only one of the departments that have an excellent staff working within them. Internal departmental meetings, have and will be held, for the purpose of encouraging all Sandy Pines and Lake Monterey staff persons to be diligent in presenting ourselves as professional, courteous, respectful, and helpful while providing our best for this Park. These and other similar servant traits are the call to them of our minimum expectation from each of us on staff.

Listening to the personal accounts of many staff persons, it is apparent that they meet challenges and opportunities each day that are unknown and/or unrealized to most of us. However, it is

PARK & GARDEN NEWS

Welcome back for the 2018 Camping Season at Sandy Pines. The Park & Garden store does not open for retail business during the first month. We open full time the last two weekends in May. Our hours this year are Monday–Saturday 9 am to 4 pm and Sunday hours, which begin in June, will be from Noon – 4 pm.

From April 10 until the weekend before Memorial Day we will be setting up water softeners, getting the golf carts ready for rental and preparing the store for the opening. There have been some changes over the winter, and you will notice them when you drive up to Park and Garden.

The system for reserving golf carts and watercrafts is online and running well. If you are in need of a golf cart for this summer you can make reservations through email (parkgarden@sandypines.com) be sure to include your email, phone number, date and time to pick up the cart, how many days, type of cart (4 or 6) and campsite number. You can also call our Golf Cart Reservation number **616-896-9888** and leave a voice mail with the dates you will be needing the cart, size of cart (4 or 6), campsite and phone number. We will then enter the information into the reservation software and you will receive a confirmation email.

Golf Carts can be rented beginning in May. We have a special preseason rate before Memorial Day. New this year, we will be renting on a day to day basis. Rent Friday (anytime pickup) and

return on Sunday by 10 am – considered a two day rental. Four (4) passenger rental has been lowered this year to \$50/day and the Six (6) passenger is the same as last year at \$65/day. The 4 passenger carts are electric with a charger onboard and the 6 passenger carts are gas.

The online web access set up for reserving golf carts and watercraft is also located on the Sandy Pines web site. Click on the button link to go to the reservation site. There is a fee for using this service, so if you want to avoid the fee, you can still reserve by calling Park and Garden, stop by the store, or email us to make reservations. Always remember that holiday weekends and on special event days, carts are in high demand.

Even though the store is not open during April and May we will be checking voicemail and email every day for your messages. We should respond to your calls and emails within 24 hours. We will have mulch, and stone available for delivery. We can make delivery of bulk products during April and May on Tuesday, Thursday, Friday, and Saturday, by appointment.

If you need your boat put in the lake, please call and set up an appointment with the store–616-896-9334. We will begin this service in April, but you will need to call at least 48 hours in advance for an appointment.

For those of you who came in and reserved a water softener before you left in the fall, you should have received an email from the store to confirm your reservation and hook up date. It is important that you respond to the email. We will begin installing the softeners as soon as the water is turned on in April. **Please remember that we cannot hook all of them up the first week, so if you aren't planning on being in the park first thing, we ask that you give us a firm date to install and we will attempt to have it ready when you arrive.** We need to be able to find your hose at the riser, so we hope you marked it well last fall. Also, if you have any hoses that are used to

hook up the softener, please make sure they are out and ready for us to install. You will be billed on the April or May statement for the softener and installation.

For those who are doing a self-install we are going to make scheduled times for you to stop by and pick up the tank. Since we have changed the front of Park and Garden, we will have a new location to pick up the softener. I will have directions on the door to the Park and Garden. We will be at the store on Tuesday, Thursday, Friday from Noon to 1 pm and again from 5–6 pm. Saturday will be by appointment only.

If you did not reserve a softener in the fall, you can still get on the list. The softener is a great way to keep the rust off your sink, tub, etc in the trailer. It is not meant to stop the smell that we sometimes get during the summer, but it can help. Stop by the store for more information on the softener and/or the smell.

NEW this year we will be renting small tools, wheelbarrows and other items to help with your summer activities. We also have bicycles for rent. They can be rented through the Park and Garden Rental Office. Enjoy some exercise as you ride around the park. Let us take care of maintaining the bike for you.

As you begin getting your supplies for the season, remember that you are to use holding tank chemicals **without** formaldehyde. Formaldehyde has a detrimental effect on the septic system. Help us keep the system working efficiently.

EMERGENCY SERVICES DEPARTMENT NEWS

Smoke Detectors and Egress:

Upon arrival to your site this spring, please change the batteries in your smoke detectors. Always verify that your smoke detectors are in working order and replace them if they are not functioning. Smoke detectors are very inexpensive. Camping units have very combustible materials and commonly burn very quickly. Please take the time to service your smoke detectors to protect you and your family.

Be sure to review the exits in your camping units for clutter or anything blocking them. If blocked, please take the time to move furniture or clutter away from the exits. The time to move items is not when you are having an emergency or have

emergency medical personnel trying to access you or your family.

Carbon Monoxide detectors: If you do not already have a carbon monoxide detector in your camping unit, consider purchasing and placing one in your home. Carbon monoxide is an odorless gas that is deadly.

If you have a loft in your camping unit, please do not place a window mount air conditioner in the only window or exit in the loft. In the event of a fire, if the window is blocked by an air conditioner, this prevents the availability of an exit.

MAINTENANCE UPDATE

This off season was our busiest ever! Below, are a few of the projects that kept us busy.

Lots of renovations at the Retail Center. We built a new library, new hair salon, new Inspector's Office and a Rental Office space for Park and Garden.

New Park & Garden bins were built and they are located behind the Maintenance Building. The old Park & Garden bins were removed and replaced with additional parking area. The Propane Tank was moved to the Retail Compactor area.

We made improvements to the entrance at CC#11 and demolished CCs 5 and 6. The new facilities are coming along well. We will be able to occupy them on April 16th and the finishing touches will be completed before May 15. We will be working on updating the landscaping and parking area as the 2018 season approaches.

We have cut a lot of trees around the park that needed to be removed and have trimmed the brush along the road edge in Phase 3. We also

cut trees and added fencing along a farmer's field and cleared trees on the drain field for CC#12. We have been working on grinding the stumps throughout the park.

Lighting was replaced with new LED lighting in the Administration Building, Maintenance and Retail Laundry. We have painted many of the offices and CCs and have 'winter cleaned' all of the buildings. New mirrors were installed in CC #13, new furnaces were installed in CCs 1 and 4. Two new water softeners and water heaters were installed.

We have made Playground improvements in Phase 5 and renovated existing campsites in Phase 3.

The recycle bins will be available at the dump the first of April. This is the short list of some of the improvements you can expect to see upon your return...compliments of the Maintenance Department. Welcome Back!



PUBLIC SAFETY OFFICE NEWS

PARK ENTRY RULES AND PROCEDURES

Some questions have arisen recently regarding park entry rules. As it is the beginning of the season, now is a good time for a quick review regarding this topic. For Member, Associate and Grandchild entry, the membership must be in good standing and the individual must possess a current membership card and Sandy Pines Vehicle Registration Sticker. Member and Associate access cards will permit entry into all perimeter entrance gates. Associate members and Grandchildren under the age of 18 are only permitted access to the Main Gate and Phase Three Gate. For Associates and Grandchildren under the age of 18, the member/owner or the grandchild's parent, an Associate Member, must be present in the Park when a Grandchild under the age of 18 is present. Membership cards are non-transferable. Persons found to have an access card which is not authorized, will have the card confiscated or deactivated. The person whose name appears on the card may use the membership card to gain access to the Park. Access areas are monitored, so please do not use a valid card to scan other persons into the park. If there are circumstances such as a card left at home, etc., please call the Public Safety Office at 616.896.9006 to advise on-duty staff of these circumstances. Regarding Guest Entry, a guest must be registered by name by a member/owner. It is the responsibility of the member/owner to register the guest. This can be done through the website or at one of our remote terminals at the Main Gate Station. If you require assistance, our staff is happy to help. In the event you have forgotten your username or password, stop or contact the Main Gate Station, and we will assist you. Associate Members or Grandchildren do not have the privilege or authority to bring guests into the Park or to register guests. A guest may enter the park as a passenger in the member's vehicle without registering. If the vehicle is not owned by the member/owner, the guest would have to be registered with the Park as a guest and the vehicle would require a guest pass. The member must be present during the guests stay within the Park. The member/owner is

responsible for the actions, conduct or damages caused by the guest. It is a violation of Park rules for members to allow illegal entry in the Park by a guest. An example of this would be picking up a non-member at a neighboring business and bringing that person into the park. A fine of \$100 may be imposed for such actions. Associate Members are not required to register their minor children as guests when entering the Park with the Associate Member/parent. One final note on this topic regarding Associate Members and guest's: Per current Park Rules, the member/owner must be present in the park during a guests visit in addition to signing those guests in. A member/owner who signs guests in and allows an Associate Member to bring the guests into the Park when the member/owner is not in the Park violates of Park Rules.

VEHICLE REGISTRATION STICKERS

All vehicles in the Park must have a current Registration Sticker. If you have a different vehicle this year, please stop at the Main Gate Station and bring your registration from the Secretary of State with you. A new sticker can be purchased for \$2. Golf cart and moped stickers may also be purchased at the Main Gate Station or Member Services. All carts and mopeds must also have a current registration sticker. Side by sides, ATVs or other types of off-road vehicles are not permitted in the Park.

GOLF CART DRIVING PERMITS

Minors age 12 or older must complete the Golf Cart Safety Course to operate a cart within the Park. Upon passing the test, minors age 12 are allowed to operate the cart with an adult 18 years of age or older. Minors age 13 or older must also complete the Golf Cart Safety Course. Upon passing, and after three weeks of operating with a licensed adult, are allowed to operate the cart in the Park. We are frequently asked for a hard copy of the study guide for the Golf Cart Safety Course. We are able to provide a hard copy of the Study Guide at the station for a fee, but a better alternative for most is to find the copy of the Study Guide on the website.

MEDICAL AND OTHER EMERGENCIES

For all emergencies requiring a response, please call 911. After calling 911, please call our main station at 616.896.9006 to advise of the emergency. Our Safety Team includes Paramedics, EMT's and First Responders. We are able to provide a quick response to emergencies. All patrol vehicles are equipped with medical equipment and a fire extinguisher. We also have a room equipped at our Main Station for medical issues. Our staff are more than happy to check vital signs such as blood pressure, pulse, blood sugar and oxygen saturation upon request. If you or a relative may be experiencing a problem, please contact us. Time is of the essence with many medical issues, and it is our privilege to provide medical assistance to members and guests.

RENTAL GOLF CARTS

This issue came up several times over the past season. Rental golf carts must be driven by persons at least 18 years of age with a valid State Operator's license. They may not be operated off-road or on public roadways. As an example, a person meeting these criteria would be in violation if he or she rented a cart then allowed a person not meeting these criteria to operate the cart.

MOPEDS

This is also an issue which was encountered last season. Persons operating a moped in the Park must comply with both State of Michigan law and Park Rules. Operators of mopeds must have a State of Michigan moped license or Michigan Operators License to operate a moped in the Park. The moped must also be registered with the Park and display both site numbers and the Park Moped Registration sticker on the rear. Michigan law further states the following: "A two or three-wheeled vehicle with a motor which has no more than 50cc piston displacement producing two brake horsepower or less. The moped must have a power drive system that does not require shifting gears and cannot have a top

speed exceeding 30 mph on level surfaces. If the vehicle is capable of speeds greater than 30 mph or has more than 50cc displacement, it is considered a motorcycle under Michigan law, and the operator would be required to have a valid full Michigan Operators License with a Motorcycle Endorsement.

CONVENIENCE CENTER PARKING

This section of the Handbook was amended on 08/18/2017. The new rule states "No overflow/overnight parking at the CCs. A \$100 fine will apply if you are in violation." This was also an issue last season with numerous complaints of CC lots being used for overnight parking, in many cases by vehicles without a valid Park registration.

NEW EMPLOYEES

There are several new employees on the Safety Team. Shawn Brundzo is a retired veteran who served his country with distinction in the US Air Force. Drew Torres is a retired police officer and veteran of the armed forces. Drew is also a resident of the Park. We are thrilled to have Drew and Shawn join our team. Please take a moment to introduce yourself, if the opportunity presents.

CPR TRAINING FOR RESIDENTS

There have been several inquiries about The Park putting on a CPR class. Our staff would be happy to put a class together if we have enough interest. We would need at least six persons for a class. The cost would be \$25/person. The class itself would be four hours in duration, and would result in certification in CPR. For any interested persons, please email keith@sandypines.com.

We would like to thank all members for continuing to make timely payments on your account. With the new season just around the corner, I would like to remind members of the multiple payment options available to you:

- **IN OFFICE** – Cash, Check or Credit Card payment – Please note the Public Safety office is available to take payments 24/7 as well, in person only.
- **MAIL** – Check payment – Please ensure your site number is included to ensure proper posting of your payment. Please note, payment will be posted on the date your check is received not the mail date, so please allow adequate time for delivery.
- **PERSONAL ONLINE BANKING** – Manage your payments through your own banking system, to authorize the online banking to submit payments directly to Sandy Pines Wilderness Trails. This can be a recurring amount to cover your balance or a specific amount set each month. Provide your banking institution with the Sandy Pines main address: 2745 136th Ave, Hopkins, MI 49328, as well as your site number, to ensure proper submission of your payment.
- **ONLINE BILLING** – Make a payment on your account using your MasterCard/Visa/Discover. Convenience fees for credit card payments made online or over the phone (MasterCard/Visa/Discover Cards) will be 3% of the total payment made. The point-of-sale will allow your payment to be reflective on your account immediately.

- **ACH AUTHORIZATION** – Select one of our three monthly 'auto payment on account' options which include: Balance on Account, Fixed Payment Amount, or a "Will Call" with amount. Once we receive your completed and signed form with a voided check, we'll activate automatic payments which will pull from your account on the 25th of each month. It is the member's responsibility to cancel the option for automatic payments if the need arises.

- **RECURRING ACH AUTHORIZATION** Set a designated amount to pay every month that in time will create a credit balance to cover your dues and assessments prior the new season.

The Independent Annual Financial Statement review by Beene Garter is scheduled during the month of April to review the FY2017 Financial Statements. The Board has received all financial statements through February 2018 for review, however was not able to approve financial statements during the off-season. - 7/1 Deadline to return renewal stickers for credit
- 10/1 Annual Dues, quarterly final adjusted electric & state tax billed (Due 10/25)
- 10/15 Water is turned off for the season (weather permitting)

5 THINGS YOU NEED TO KNOW

1. **ANNUAL DUES:** If you are making monthly payments your account balance as of March 25 should be at \$0.00 and your account should be paid off completely. Any unpaid balances may result in finance charges and lead to deactivation of membership cards.
2. **ANNUAL RENEWALS:** The deadline for updating your annual renewal summaries

was March 15. We are not able to credit accounts for services charged or adjustments made after this date. The total amount from your renewal statement was billed on your April statement with payment due April 25. Please also note your April statement includes your quarterly electric and state unit tax which is billed in April, July, October & December. Membership cards cannot be canceled for credit after the March 15 renewal deadline. Purchasing of new membership cards are not related to renewals; they require a photo and can be purchased in person anytime at the Main Gate. For questions on membership cards, please contact the Public Safety Office directly at 616-896-9006.

3. **STICKERS & STATEMENTS:** Stickers are automatically mailed with your April statement to the primary address listed in your Member Web Access Portal, unless you request we hold them at the Main Gate. **Once stickers are mailed they become your responsibility and we must charge the full price for their replacement. The deadline for crediting returned stickers is July 1st.** If your boat registration expired prior to April 1, your boat sticker will not be included with your April statement however you'll still be charged for the sticker. Once we receive your updated boat registration we can provide your sticker. If for any reason you don't receive your April statement and

stickers, check your mailing address by logging into your Member Web Access Portal.

4. **CABLE & INTERNET:** Spectrum Technicians will soon be back in the park for spring installs. All installations and service calls need to be scheduled through Sandy Pines Member Service. Per changes Spectrum has experienced with their recent merger, they must have a job number to visit any site for service calls. Without a job number, they simply cannot visit a site not on their approved list – it is an infraction for them to do so and we want to protect their procedural compliance. To activate Charter bulk internet service contact Sandy Pines Member Service at 616-896-8315 before May 15th. For more details visit www.sandypines.com/cable-internet-phone-services.
5. **MAIL SERVICES:** At the beginning and end of each season we recommend you complete your seasonal mail forwarding requests one month in advance of your transition to the park as it can take two to three weeks for the change of address to take effect. While UPS & FedEx are not able to deliver parcels and packages in the park, we've allowed members to have packages delivered to Member Service. For information on park USPS mailboxes and details on our mail policy and parcel delivery, please visit www.SandyPines.com/MailServices.


