BOARD OF DIRECTORS UPDATE

If you were to randomly survey ten Sandy Pines Members asking them their favorite park activity, there might be ten different answers. But if you were to ask their top ten, there is little doubt that Lake Monterey would make everyone's list. It is a valuable asset unlike any other at SP, offering a wide variety of options for young and old alike.

Just think about all the enjoyment our lake provides. Wonderful sandy beaches with safe waterfronts, boating choices galore, calm swimming spots, the tranquility of Phase 3, the diverse amphibious habitat of the channel, plenty of opportunity for kayaks, paddle boards, pedal boats, and sailboats. Fishermen live the dream, always "angling" for their perfect, secret spot. And let's be honest here, who hasn't yelled "hey!" really loud when going through the tunnel. Even non-water users benefit as demand for Sandy Pines properties remains high, undoubtedly thanks in part to the lure of Lake Monterey.

Yet its diversity is accompanied by challenges. How do we meet the demands of all the

participants? The boaters and bathers want clear water while the fishermen like weeds and depth. And while some types of weeds are OK, others are undesirable. The no-wake areas of Phase 6 and Sailboat Cove give many peace and quiet but the lack of water movement and depth result in water quality that becomes questionable increasingly so as the season progresses. Boat traffic in general creates its own set of issues, leading to excessive erosion in certain areas and potential safety hazards.

Tackling these topics is the task of a newly created lake committee, a 12-member, all-volunteer group that hashes through these matters weekly. Discussions thus far have been spirited and insightful, each participant bringing obvious passion to the table. The decisions reached and ultimately presented to the board for review will be well thought out and made with integrity and fairness. This group of your peers does not take this matter lightly, realizing that all findings and suggestions are vital and essential to the long-term survival of our park's most valuable asset.

EMERGENCY SERVICES NEWS

Boating

Taking the time to safely inspect your watercraft and prepare your family and friends for an adventure on the lake may determine the outcome, should an event happen while boating.

Don't take risks. If you smell raw fuel, have a qualified technician check and repair before use of the watercraft. Boat fires can severely injure or kill occupants and destroy your watercraft. Check your fire extinguisher and replace if discharged, outdated or not operational. If older than 6 years replace.

Inspect your personal flotation devices. Ensure that you have the proper sizes for each person on your watercraft.

If you are pulling a skier or tuber(s) have a competent observer. The lake can be very busy at times. If you are inexperienced, have inexperienced water skiers or tubers choose a time when the lake has less traffic.

Wear personal flotation devices that are Coast Guard approved. Each summer, multiple events occur in which a person drowns in West Michigan. Many, if not all, could have been prevented if they were wearing a personal flotation device. If you have people on your watercraft that cannot swim, have limited ability to swim or have health issues, please provide personal flotation devices, and have these individuals wear them. If you are boating alone, wear a personal flotation device. Children less than six years of age must wear a Type I or Type II PFD when riding in the open deck area of a boat. Please have children wear Coast Guard approved flotation devices. Should something go wrong while on the water, the

flotation device may be the means that saves a life. Ensure that personal flotation devices are used on small watercraft such as paddle boats.

Boating traffic on the lake can be very busy. Swimmers in boating lanes can place themselves at great risk. It can be difficult to see swimmers in the water with the wave action, sun, and pitch of the watercraft. Do not assume watercraft can see you in the water. Avoid swimming into boating lanes. Stay within the designated swim beaches.

COVID-19

This spring and summer are surely very different from every other year with the COVID-19 virus. Unseen, visibly undetectable, with an airborne suspension means of transmission it continues to be a risk to the health of all. Restrictions and stay at home orders have increased our want to return to our normal activities. The reality is what we have known to be normal is not what is present.

Responsibility in the spread of the virus is upon each person individually. Responsibility entails wearing a face mask when in close proximity to others (inside or outside), maintaining social distancing of 6 feet or more, hand washing and not subjecting yourself or family to gatherings of people in close proximity (inside or outside).

Safety, risk reduction, and prevention of spread to others can only be obtained by individuals following public health recommendations or mandates. Compliance is the means to protect others, your family and yourself. Behavior and attitude to wear or not wear, be compliant or non-compliant have had sharp upturns in the spread of the virus at events locally and nationally. Compliance is the means to reduce the opportunity of the virus to spread and return to a normal world. Non-compliance and spread are the means that causes facilities to be closed. As we move forward please look farther than yourself, wear a mask, social distance, use good personal hygiene, and follow guidelines to continue to have the opportunity to utilize Sandy Pines and enjoy what is offered in this abnormal summer.



Bike Safety

Wear a helmet – a properly sized helmet can reduce or eliminate a traumatic head injury or death.

- Wear Bright clothing and bike during the day light hours. Be visible. Don't assume others see you.
- Follow the same traffic rules as motorists.
- Never hitch onto cars or golf carts.
- Ride Single file with the flow of traffic.
- Use hand signals. Let others know what you plan to do.
- Supervise and accompany children on the roadways.
- Refrain from permitting small children with toys to play in the roadway. Children on small toys may not be easily seen or visible to motorists.

Youth Golf Cart Safety

Please refrain from permitting small children to ride on the lap of a driver. In the event of a crash with an object the weight of the driver and the force of the impact will cause the child on the lap to be forced into the steering wheel of the golf cart.

Financial Statements

The most recent June 2020 financial statements for both Sandy Pines Wilderness Trails and Lake Monterey Golf Course have been approved at our July Board of Directors meeting and posted on the Finance Page at [SandyPines.com/Finance](https://www.sandypines.com/Finance).

Sandy Pines update

- Operation Cash as of June 2020 is up approx. 42% over prior year, due to the receipt of renewals payments in June, in turn resulting in the reduction of Member A/R from May to June 2020.
- The balance in the Operational Cash account also includes the receipt of the PPP Loan funds approx. \$512k.
- The Charles Schwab Investment Account as of the end of June is up \$130k, approx. 7.7%.
- Current liabilities are up \$626k, primarily related to the currently liability hold of the PPP loan of \$512k.
- Total Net Income is down \$55k, approx. 3.3% from prior year, compared to \$276k or approx. 16% last month. The reopening of activities within the park has helped in turning this around.
 - Sales and Hospitality Net Income is down \$60k, compared to \$200k last month.
 - This is due to added interest in prospective members buying sites and is a significant help with recouping the loss of Site (Camping) Rental Income which is still down \$210k as of the end of June.
 - Administration Net Income is down \$130k. Flea Markets have been cancelled through the season.
 - Maintenance Net Income is up \$50k. The majority of the decreased revenue continues as a result of the delay of maintenance services with the shutdown and the increased expense is related to ground maintenance costs with repairs completed in the off-season.
 - Public Safety Income is down \$20k. This change is specifically related to a decrease in guest fees and violations with the stay-at-home order and restrictions and lessened mag card income.

- Recreational Net Income is \$15k higher than prior year. Salaries and wages year-to-date are lower due to the delayed season and set up of employees.
- Resort Services Income is up \$250k. Operational expenses are down \$120k compared to prior year.
- Park and Garden gross sales is up \$10k and the cogs is also up \$16k. Park and Garden has great product needs for our members and guests and Administration's focus is to continue turning the product sales.
- Rentals Income is down \$30k related to the cancellation of multiple golf cart reservations related to the Pandemic restrictions and a slower restart.

Lake Monterey Golf Course update

- Operation Cash as of June 2020 is down approx. \$20k or 5% over prior year.
- The balance in the Operational Cash account also includes the receipt of the PPP Loan funds approx. \$35k.
- Current Liabilities are in line with prior year, but all include the holding of the PPP funding.
- Total Gross Revenue is up \$47k or 11.8%.
- Total Operational Expenses is increased \$40k. The stay-at-home order and delayed activity on the greens has helped recoup some of the previous expense in the off-season making repairs to the course and uncompleted maintenance projects during the month.
- Total Net Income is up \$27k.

One thing we would like for you to keep in mind, if you did not return to Sandy Pines this season is to remember to have your site winterized, or at least checked on. There is always a possibility that someone may have hooked up the wrong hose and water was run in your trailer. It is a good idea not to take a chance that your trailer will still be good for another winter, even though you were not here. Please

remember the Maintenance Team can only do a certain number of winterizings, and it is always on a first come...first served basis.

The hot weather this season has impacted the electric here at Sandy Pines and in other areas, as well. We have been in contact with Consumer's Energy. They have installed new regulators to help provide you with adequate power. If you call Consumer's Energy about a major power

outage, please give them this address when they ask: 3681 – 28th Street, Dorr, MI 49323. You need to tell dispatch to have the Consumer's Energy crew report directly to the Public Safety Office for further instructions. This will help with the Consumer's Energy response time, and hopefully eliminate any confusion. This is only for major outages. Please contact the Maintenance

Hold My Stickers!

If you know you want your stickers held next season you may tell us now or before you leave for the season and we will fill the form field. This prevents your stickers from being lost in the mail. They are placed in an envelope and sent to the Main Gate so that you may pick them up when you arrive in the Spring. You will still have the opportunity to decide during the Renewal period, January 15 to March 15, 2020 to have your stickers held. Thank you.

Annual Election

Absentee ballots are available at the Member

Service Office 30 days before the election. Absentee ballots must be mailed or deposited in the ballot box at the Member Service Office no later than 4:00 pm on Friday, August 21, 2020. Photo ID is required for Member identification – i.e. Sandy Pines photo member ID card; driver's license, etc. For voting purposes, each membership, whether owned individually or jointly, shall be entitled to only one vote. before September 30th are \$80 and your keys must be in the office by September 30th to get the discount. Winterizations on or after October 1st are \$100. The latest departure date is October 15th. We are not able to winterize trailers that have hot water heaters located on their porch or trailers that share a water line.

Cable & Internet

Thank you for your patience, as together we have struggled with cable and internet issues this season. Please know that we do understand your frustration, as we also experience it. Also know that the technicians who work in our park are not the cause of the issues with consistent service and ability to get appointments – the “boots on the ground” do a great job.

Some Members are set to receive new modems, some are not. This is because some modems already in the park are compatible with the new speeds to which we have been upgraded. Our

new contract provides 200 mbps download and 10 mbps upload speeds; the previous was 60 DS and 4 US. We are working as quickly as possible on modem swaps, but due to the required tracking, it takes tremendous attention to detail. With the volume of calls and emails we are receiving, we must take our time to get it right. Thank you for your patience.

One small thing you can do to try and help control line noise is to unplug your electronics and cap unused lines and splitters at the end of the season, especially, if you disconnect and take your TVs and routers home. Those exposed ports and pins can cause line noise. Capping isn't a surety that noise won't happen, but capping can help. Caps will be available at Member Service at no cost to you. We'll continue to help trouble shoot as much as possible.

Pump Outs

If you think your pump out may have been missed, the first step is to check your tag to see

if it was punched. If punched, you did receive a pump out. Whether by indicator or visual check, you see that your tank still seems full, you may have a clog. You can take a stick and gently try to loosen debris – you will hear it go down. If this does not work, you may need to call Vacationland. Mistakes do happen, but please make sure you've checked all the above before calling Member Service or Maintenance. These are the first questions we will ask you.

If you need an Emergency Pump Out, please remember, if needed the same day, you cannot book EPOs online – you must call Member Service or leave a message on the EPO line at extension 111. Emergency Pump Outs are done at the earliest, after the regular PO route, but most often between 1pm to 2pm. We cannot guarantee an EPO if you wait until 2pm to call. The crew is generally finishing, washing the trucks and cleaning up for the day. Thank you!

Pet Rules

Members are reminded that pets must be maintained and controlled on a leash. Members are responsible for cleaning up after pets. Pets are not allowed in any designated swimming areas. The rule section pertaining to pets can be found in VI, section E.

Boat Registrations

All boats must be registered with the Park. Security Services understands that registration with the State of Michigan may be delayed due

to COVID19, but there is no grace period for registration with the Park. Not registering the boat with the Park is causing substantial issues for staff as we cannot track the proper owner and may in certain circumstances have no choice but to impound the boat and charge the site for the removal and storage fees.

Boating Rules

The following are several frequent violations being found on Lake Monterey.

- Motorboats are to be driven in a counter clockwise direction around the lake.
- Watercraft must stay at least 100 feet from shoreline, swimming areas and moored boats.
- No powerboat may exceed 10 mph before 10am or after 10pm.
- Alcohol is prohibited on boats.
- Each person onboard a watercraft must have a USCG approved and proper type of flotation device. Children under six years of age are required to wear a Type I or II PFD when riding on the open deck of a watercraft.
- The driver of a watercraft pulling a tuber or skier must have a competent observer. There is a zero-tolerance policy for violations of this rule and a violation will be written.

Golf Cart Testing

Golf cart testing has been a great success. The testing was conducted outside with adherence to social distancing. I wish to thank Sgt. Bruce Maurer for his work on this as well as extend sincere thanks to the following volunteers: Sue Stank, Bob Griffin, Jo Maurer, Bruce Walcott, and Brenda Hibbs.

Overflow Parking

Boats and trailers may not be stored overnight in overflow parking areas. It does not matter if the boat or trailer is attached to a vehicle.

Membership Card Abuse

It is always improper and a violation of rules to scan another person in or allow another person use of a card for access. This is a 10 point \$100.00 violation. Please register your guest and remember a Member must be present when a guest is in the Park.

Executive Order 2020-147

EO 2020-147 mandates the following:
Acting under the Michigan Constitution of 1963 and Michigan law, I order the following:

- Any individual who leaves their home or place of residence must wear a face covering over their nose and mouth:
 - When in any indoor public space

- When outdoors and unable to consistently maintain a distance of six feet or more from individuals who are not members of their household.

The State of Michigan enacted penalties of a misdemeanor offense and fines of \$500.00 for violations. The Park has enacted a similar rule

with \$500.00 in fines for violations. Please wear masks and adhere to the guidelines.

The site capacity remains at 8 persons. Any number of people greater than 8 on a site is a violation.

On 07/16/20 our office was contacted by Dr. Rebecca Vincent who advised the falcon had experienced a head injury but was recovered and believed able to fly. Dr. Vincent wished to release the falcon in the area where it was at the time of the injury. Dr. Vincent and staff transported the falcon back to the area where it took flight immediately upon release. Thanks all who aided in the rescue and rehabilitation efforts. Keep an eye out whenever you're near Sailboat Cove as you may see this bird back in it's natural habitat.

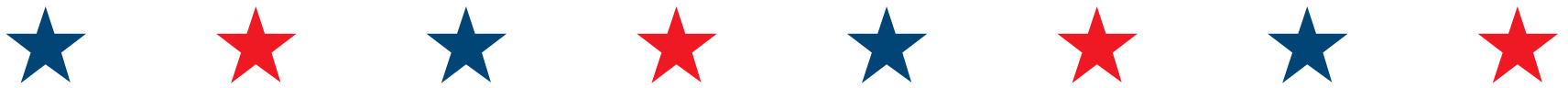

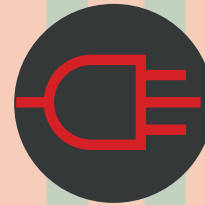
