The fitness center has a new floor installed just in time for its opening. Handbook Rules

Last year as we all know was a very challenging year. Our focus was opening the park, maintaining COVID-19 rules and protocols and with that some of our other Handbook rules were gracefully overlooked. FEMA Building

The opening of our new FEMA building remains on track. Windows which were delayed due to supply chain issues resulting from COVID are finally installed. The finishing touches are being done with a final walk-through taking place this month. Occupancy is targeted for the end of March 2021. Once we have the final occupancy approved, Kentwood Office furniture will be delivery and installing furniture throughout the building. We are excited to show this space to our members as well as our local and state government officials who helped to make this happen for Sandy Pines.

Cart Bridge Project

We continue to progress with this project. The team met with Allegan County Road commission to receive approval on the submitted plans. This project will be bid differently than the FEMA project as our cart bridge is privately funded, sourced project. Bids are out with two requested completion timeframes: May 2021 and November 2021. March Board of Directors Meeting

This month we will be meeting with our board of directors to discuss many topics in prep for the season. Our Lake Study Committee has met to again provide recommendations to the board to hit the ground running with projects to protect our lake as well as make it safer for all to enjoy. We would like to Thank Jim Buchanan for stepping up to lead the Lake Study Committee in replacement of Stephanie Saypanha who moved into a

board of director role. Jim will do an excellent job leading this committee for Sandy Pines. We are excited to get to work on these recommended projects.

We will also provide additional information to the board regarding the IT project and upgrades. Our IT assessment team and Technology Committee Chair met with DPT Solutions. DPT presented through solution through Office 365 Dynamics. their Information presented during our meeting will be presented to the board with a solution provider recommendation.

50th Anniversary Sponsorships

We thank the Chapel committee for allowing the use of their area for some of our planned events. Currently our funding is at approximately \$28,000 which is a slight increase from January. BOARD OF DIRECTORS UPDATE

There are several factors taken into consideration when the board is tasked with the possibility of bringing physical improvements to the park. Cost/benefit analysis is certainly a factor as well as funding sources. Surveys often come into play in addition to Q & A sessions at face-to-phase meetings. Member comments and questions to the board are an excellent source of ideas and give us a gauge as to the pulse of the park as a whole. When all is said and done though, while many different methods are used, the common goal is always, how will this benefit the park and the members?

The current path connecting phases three and six is inherently dangerous. Relatively slow-moving objects (carts, bikes, pedestrians) attempting to traverse a thoroughfare dotted with 3000-pound objects hurtling at 55-65 mph and sketchy sight lines is a recipe for disaster. We have been extremely fortunate to have dodged a catastrophe to this point and we'd like to keep our clean record intact. Thus, the decision has been

made to have a bridge built to connect these parts of the park making safety a top priority with this particular project.

The bridge will be located at the same place as the current crossing, extending slightly into each phase. Security will also be enhanced as there will no longer be easy access points for outsiders to trespass, a current thorn for the park. Contech Engineered Solutions has assembled an extremely detailed set of plans that have met all state standards and is now in the hands of the Allegan County Road Commission. As soon as we receive the OK and finish any minor tweaking and cosmetics, the final drawings and renditions will be made available for public viewing. This should happen in the very near future. Final bidding from competing firms will be considered with construction to commence shortly thereafter.

While the bridge will easily be wide enough to accommodate two golf carts side by side, there will not be additional lanes for bikers and walkers

so there will be a learning curve for courtesy. It will also be recommended that bikes be walked across as they are difficult to control on upgrades and could become dangerously fast on downslopes. There could be other guidelines as the project evolves and we all learn together.

The cost to build is obviously not small but, thanks to the fiscal prudence of this and previous boards, there will be no additional costs to burden the members, a truly remarkable feat especially given the financial hit many have had to absorb recently. And, frankly, what it boils down to is this. Would you rather be thinking, "why are we building this?" Or would you rather be saying "why didn't we build this?" after a tragedy strikes. 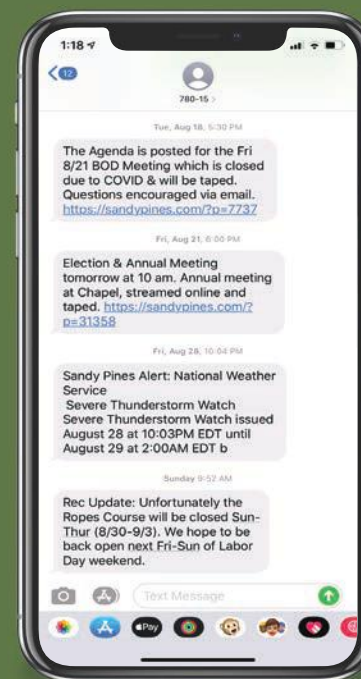

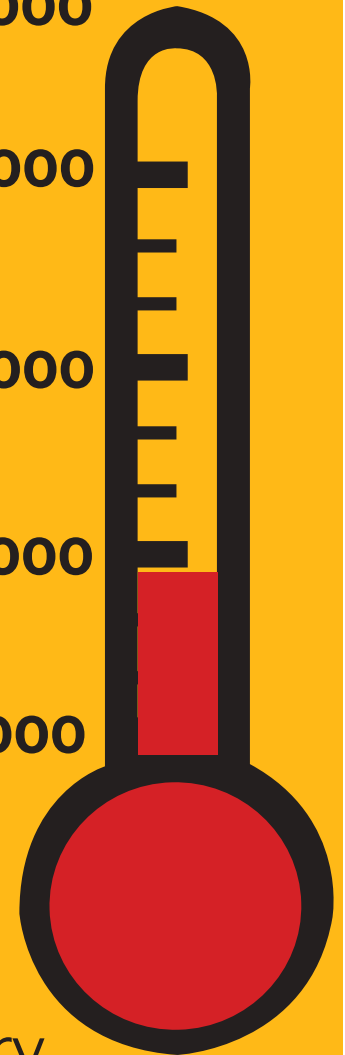

Fitness Center Rules

The Sandy Pines Fitness Center is now open! Please follow posted guidelines. We will post updates to guidelines as we receive them.

Severe Weather

Please take the time to discuss with your family your emergency plan for severe weather.

Discuss where you plan to take shelter, where to meet after a storm (if separated), where to take shelter if out in the park and what to do if out on the lake.

THE SANDY PINES FITNESS CENTER IS OPEN. PLEASE FOLLOW THESE GUIDELINES WHEN USING THE FITNESS CENTER:

1. IF YOU ARE SICK OR HAVE RECENTLY BEEN SICK, PLEASE STAY HOME.
2. PLEASE WASH YOUR HANDS FOR 20 SECONDS PRIOR TO USING FITNESS CENTER EQUIPMENT AND WASH YOUR HANDS FOR 20 SECONDS AFTER YOU COMPLETE YOUR FITNESS CENTER WORKOUT.
3. PLEASE KEEP YOURSELF SAFE BY REFRAINING FROM TOUCHING YOUR FACE, EYES, NOSE, OR MOUTH DURING YOUR WORKOUT.
4. A FACE MASK MUST WORN WHEN INSIDE THE FITNESS ROOM PER STATE GUIDANCE.
5. CAPACITY IS RESTRICTED TO 25% PER STATE GUIDANCE OR 4 PERSONS. PERSONS SHOULD BE CONSIDERATE OF OTHERS AND PLAN TO ROTATE EVERY 30 MINUTES IF OTHER PATRONS ARE WAITING.
6. PERSONS MUST SOCIAL DISTANCE AT LEAST 10 FEET FROM OTHERS.
7. CLEANING/DISINFECTING PRODUCTS ARE PROVIDED. PATRONS MUST DISINFECT EACH STATION PRIOR TO USE AND IMMEDIATELY AFTER USE. PLEASE BE CONSIDERATE IN PROPERLY CLEANING AND PREVENTING THE SPREAD OF COVID-19 BY PROPERLY CLEANING AFTER USE.

Severe Thunderstorm Watch

This means that atmospheric conditions exist that could produce severe weather such as lightning, high winds, heavy rains, sleet, and hail.

Severe Thunderstorm Warning

This means that severe weather associated with thunderstorms is occurring such as high winds, lightning, hail, and sleet and flooding.

Tornado Watch

Atmospheric conditions exist that could permit the creation of a tornado.

Tornado Warning

A tornado warning means that a tornado has been sighted or detected on radar.

Tornados often, but not always, occur in conjunction with a severe thunderstorm.

Early Warning Preparation Suggestions

One of the most important things you can do to prevent being injured in a tornado is to be alert to the onset of severe weather. Most deaths and injuries happen to people who are unaware and uninformed.

Be aware of changing weather conditions and weather forecasts. Listen to local radio and television stations.

Purchase a NOAA weather radio. Weather radios have an alert tone that activates when watches or threatening weather approaches. This will alert you and your family to changing conditions and wake you as you sleep.

Please take the time to discuss your family emergency action plan with your youth in the event of an emergency. This should include when to shelter, where to shelter, where to meet after an event and who to contact if you become separated or unable to locate family members.

Multiple resources should be monitored as well as personal observations used to seek shelter. Persons should seek immediate shelter when conditions are observed or reliable sources indicated that a weather event may occur that may be a threat to you or your family.

Disaster Kit

Please take the time to assemble a disaster kit to assist you and your family before and after a disaster. Here are some items suggested by FEMA to include:

- A flashlight with spare batteries
- A portable battery-operated radio and spare batteries
- A first aid kit with any medications needed for family members.
- Emergency food and water.
- Manual can opener
- Sturdy Shoes and one change of clothes per person
- Candles and matches.
- Cash and credit cards
- All items should be packed in easy to carry containers such as back packs or plastic trash cans with handles.

Allegan County Public Warning and Notification System

Salem Township has installed outdoor warning devices in Sandy Pines for your protection.

These sirens are located in Phase 1 & Phase 6.

TESTING Procedures:

4th Friday of each month at 11:00am, activated by Allegan County Central Dispatch. You should take this time to review your family emergency response plan.



EMERGENCY Activation Procedures:

When the siren activates you will hear a (3) minute "steady" tone. At this time you should seek shelter inside a basement or sturdy structure and tune to local radio and television for further instructions.

Weather Siren Activation and Testing

Allegan County Emergency Management and 911 Central Dispatch activates the weather siren located within the park. This siren is activated for tornado warnings.

The weather siren is tested on the 4th Friday of each month around 11:00am.

Weather sirens are intended to warn persons outside. Weather sirens are not intended to lessen a person's awareness of weather conditions, replace weather radios or to reduce the need to watch TV or listen to radio stations for weather changes or alerts.

Upon activation persons within the park should seek shelter immediately.

Outdoor Siren Activation Pre-Warning Siren activation Authority, Responsibility and Criteria

Weather siren(s) are activated by Allegan County Central Dispatch when the National Weather Service has issued a warning or as determined by Allegan County Dispatch or Emergency Management. Sandy Pines does not activate Outdoor Warning Sirens.

Testing of Siren(s)

Allegan County Central Dispatch will test siren(s) the fourth Friday of each month at 11:00am.

minutes for severe weather threats. Sirens will not continuously sound during threat. Additional activations will occur if the weather threat is still present. An all-clear signal will not occur. Staff will update persons taking shelter when safe to do so or after the threat has passed. This may be by a RAVE alert or in person by staff.

Location of Outdoor Weather Alert Sirens

Outdoor Weather Alert sirens are located in Phase 1, by the Phase 1 Beach, and Phase 6 by the Marina/Chapel area. Outdoor warning sirens are intended to alert persons outside and may not be audible inside buildings. It is important to be vigilant at observing weather changes, monitoring NOAA weather radio, local radio stations, local television and other sources to have the adequate time to seek shelter during weather threats.

Will an all-Clear Siren be given?

No, additional activations of the Weather Siren will indicate that severe weather threats continue. You should remain sheltered. Staff will notify each Convenience Center and Department facility upon the issuance of an all clear. Depending on the time of day and number of staff present,

safety of staff, number of staff on site this may take a while to reach each area.

Updates of Storm Threats during Shelter

You may use your electronic devices to stay informed of the current threats. However, during emergencies please be aware of increased cell phone usage and a slowdown of service or disruption of service. Staff will notify Departments and CC's when the threat has cleared and risk to the notifying staff is low.

Why are the Outdoor Warning Sirens sounded for hail and wind?

Wind can uproot trees, tip over trailers, flip boats and project flying items into the air creating a direct risk to the life safety of people. Hail can proceed a tornado and can vary in sizes from golf ball size to softball size and can injure or kill. All these items pose a direct risk to life of people outdoors.

What if we have an emergency during the warning?

Call 911 and the Security Department 616-896-9006.

What is the result of warning sirens and people's actions?

Siren activation, media reports and other means of impending life-threatening weather events must be taken seriously. Immediate shelter must be taken upon receiving notice of a life-threatening threat.

Every year, many people are killed or seriously injured by tornadoes and/or high winds despite advance warning. Some do not hear the warning, while others received the warning but did not act. This information, combined with timely severe weather watches and warnings, could save your life when severe weather threatens your area. **After you have received the warning or observed threatening skies, YOU must make the decision to seek shelter before the storm arrives.**

Which will work great to get a good frost in the ground. This will allow us to get a bucket truck on the course without tearing up the course. I went out and plowed snow for a road which also sent the frost deeper for the heavy bucket truck. With that done the infamous big oak branch on the 6th hole fairway is now gone! Also the one by the powerline off of two tee, the cherry tree on the left of side of fifth teen tee. Hole sixteen had

would have to move. It is a future consideration – what do you think, box holders?

For those who are not familiar with the Mail Building at Sandy Pines, please visit <https://sandypines.com/mailservices/>. Only Members with mailboxes and appropriately programmed proximity cards can access the building and receive mail and packages while at Sandy Pines. Mailboxes are \$35 per year. There is an outgoing mailbox on the street side of the building for those who have outgoing mail; there is a second outgoing box at Member Service. Please let us know if you are interested in a mailbox.

Account Balances

All Members, especially those who utilized the payment plan, must have their account balances to zero by March 25, 2021. Renewal billing items, along with quarterly electric and quarterly unit tax will make up your April statements, which are due in full by April 25, 2021. (There is no payment plan for renewal fees.) Renewals & Stickers

Changes to renewal billing items are due by March 15, 2021. Items billed to your account include pump out plans, card renewals, golf cart stickers, moped stickers, watercraft stickers, boat services, annual bullpens, internet, and mailboxes. Internet modems are on a 2020-2021

contract and cannot be surrendered for credit. Stickers are mailed with your April statements and once mailed, become the responsibility of the Member. If stickers are lost in the mail or lost in forwarding, you will have to pay full price for their replacement. If lost stickers are found and returned by July 1, 2021, credit can be issued for the duplicate purchase. Stickers cannot be returned for credit after July 1, 2021. You can choose to have your stickers held at Sandy Pines, but you must notify us to do so by March 31, 2021. For more information, view <https://sandypines.com/?s=renewal>.

2021 was the last year for sending out Renewal Summaries and using a Renewal Survey. Going forward, we will send out Rave alerts to remind Members it is time to log in, review and update their information. Members can simply call or email Member Service with their changes.

Boat Registrations

If you wish to have your watercraft stickers mailed with your April statements, or placed on hold with your other stickers, we must have your updated registration at Member Service by March 15, 2021. Otherwise, you will be able to bring your registration to Member Service and obtain your watercraft sticker. Any boat registrations not updated by June 1, 2021, will be deleted from the Member Account, including the boat stake and/or dock. Members can only keep boat stakes and docks by providing a current State issued

If scheduled Flea Markets must be cancelled due to COVID restrictions, refunds will be issued to the Members who booked spaces.

Flea Markets must be reserved by Members, as Members assume responsibility for all participating market vendors. If vendors are guests, they must be signed in and have a guest pass at the regular cost of \$5.00 per day (\$7.00 Public Safety Assisted). Members should book Flea Market spaces via Member Web Access or by calling Member Service. Each 10 x 20 space is \$35.00 and must be booked in advance of the market day. Please be as accurate as possible with the date for install and make sure your site is ready for the installation. We need your hoses available and your hook up at the riser well marked. - Must be operated on Park roads, designated snowmobile trails and Park designated areas.
- Must be driven in a safe manner and comply with Park speed of 10 mph.
- May not emit excessive sound or create a nuisance.
- May not be driven across sites, on recreational facilities, or in green areas.
- Operators must have a State Operator's License or State issued snowmobile safety certificate.
- Snowmobiles may be confiscated for violations of Park rules. Snowmobile will be released to the member after a meeting with the Park President.

The following are applicable sections of the Sandy Pines Handbook regarding the operation of snowmobiles in the Park.

XII. VEHICLE AND TRAFFIC REGULATIONS

(Amended 10/4/2013) A. General rules for Autos, Golf carts, Mopeds, Motorcycles, Watercraft, Snowmobiles and Scooters

1. All motorized vehicles operated or stored in the Park shall comply with Sandy Pines rules and regulations and State laws and regulations. Have insurance required by Sandy Pines and in accordance with the State.
2. Be driven in a safe manner. Modes of transportation may not be driven in a careless or reckless manner.
3. Display a current Sandy Pines Registration sticker/pass, be operable and be in good condition.
4. Be driven by a person with a valid State operators permit or Park certification.
5. Not be driven in excess of 10 mph
6. Not be operated in areas not designated as roadway or parking.
7. Have detachable mirrors removed.
8. Have all passengers safely seated.
9. Have headlights and taillights, if driven from dusk to dawn. Flashlights are not a substitute.
10. Be parked or stored properly or may be removed at the owners expense.
11. Not emit excessive sound or create a nuisance.
12. Not block exits, drives, parked on the sites of others or on sites for sale, near fire hydrants, be parked on roadways, block trash receptacles, restrict traffic flow, be parked or driven on beaches or green areas.
13. Report all accidents to the Public Safety Office and/or local law enforcement.
14. Yield to pedestrians. Pedestrians have the right of way.
15. Persons operating a motorized vehicle within

the Park are subject to submitting to a portable Breathalyzer test upon the request of a Public Safety Officer or local law enforcement.

16. All-Terrain Vehicle (ATV's), Utility Vehicles (UTV's) and Side-by-Side Vehicle use is prohibited in the Park, except for work being performed by the Park or Contractors.
17. Dune Buggies are not allowed in the Park unless they are licensed and insured for use on Michigan roads/highways. Dune buggies must be driven on roads only in Sandy Pines.
18. Autos, trucks, motor homes, motorcycles must have been registered in the last six months with the State and display license plate.
19. Obey all traffic control signs.
20. Sandy Pines reserves the right to approve or prohibit

6. Snowmobiles may be confiscated for violations of Park rules. Snowmobile will be released to the member after a meeting with the Park President. Any persons choosing to operate snowmobiles outside of these rules assumes all responsibility for their actions and may face penalties.

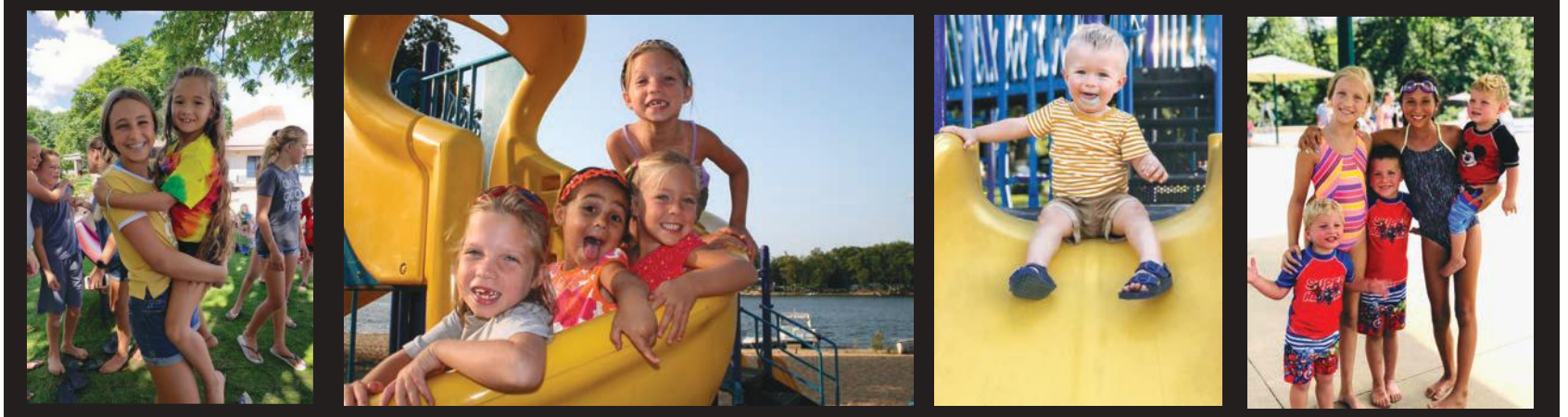
