EMERGENCY SERVICES NEWS

BY STEVE DEYARMOND

Preparing for the fall/winter storage mode:

1. Secure and place outdoor items in shelter or storage.
2. Winterize your trailer prior to freezing temps and have your holding tank pumped before freezing temps
3. Remove items that will freeze in cupboards. Remove alcoholic beverages from the park.
4. Defrost and clean your refrigerator. Place baking soda in the refrigerator to absorb odors
5. Place moth balls under your trailer to deter critters. Place decon or mouse proofer down to deter mice.
6. Place golf carts in storage or affix to a stationary object or your second golf

cart with chain and padlock to deter theft. A wheel can also be removed to deter theft. Disconnect batteries.

7. Turn off your propane tanks. Have your propane tanks filled if you plan to visit in the winter months. Have a furnace technician check your furnace for proper operation.
8. Have your watercraft winterized and place in storage. Outboard motors should be secured with chain and padlock.
9. Contact your lawn service for fall leaf removal.
10. Close vents, windows, and roll up awnings. Place pop up campers in storage mode. Have a technician check around roof vents for proper weather seal.

11. Turn off electric at the pedestal at the road.

12. Place stabilizer gas treatment in golf carts, lawn mowers, watercraft and mopeds.

13. Remove boat dock from the lake. Place boat dock on site. Boat docks may not be stored in the green area. Watercraft may not be stored on the beach or in the green areas.

14. Turn off your water at the water riser, disconnect your water line and mark your water line.

15. Make sure that Sandy Pines has your winter address and phone number. Update the park if you move in the

Rules Regarding Posting of Signs

Security Services continues to see numerous signs posted in the Park which are in violation of the rules. For information, please see the applicable rule listed below. This is found in Section VII, page 19 of the Handbook. VII. POSTING SIGNS (Amended 10/4/2013) Signs may not be posted on Park buildings, trees, or property without Park consent.

A. For Sale Signs:

1. For Sale signs are permitted that are 8 1/2 x 11 inches.
2. For Sale signs must be attached to the item that is for sale and must be located at the Member's site.

3. For Sale signs may not be attached to trees or Park property.

B. Election Signs:

1. Candidate, opinion or proposal signs:
 - a. Election signs may be no larger than 18" x 24".
 - b. Election signs may be displayed 30 days prior to the election and must be removed seven days after the election.
 - c. The candidate's name may not appear more than twice on any membership for the advertisement for the election to an organization or Park Board.
 - d. Only the member of Sandy Pines may

LETTER FROM THE CHAIRMAN OF THE BOARD

The Fall Season is upon us, and it is the time many people begin to switch gears in preparation for the back to school activities, take steps to get ready for the change to cooler weather and, yes, old man winter.

At the August 16 Board of Directors meeting we welcomed 17 new members. Seventy Six percent are working members whereas 24 percent are retired. We want to give them a warm welcome. Their names are listed later in this newsletter. The Board approved the June 2019 Financial Statements for Sandy Pines and Lake Monterey Golf Course. The Board also approved the financial budget for the 2019-2020 year for Sandy Pines and Monterey Golf Course. It was a pleasure to represent the membership of Sandy Pines. I want to thank many members for comments of support during my tenure as Board Chair. It is now time to turn the mantle over to others who also find this to be a great place to be during the summer. A big thanks to my fellow board members who all feel that Sandy Pines is also known as that "Happy Place". They all have been great to work with, their unselfish willingness to give of their time, knowledge and wisdom to always do what is best for Sandy Pines and its membership is evident in the decisions they make. I leave the Board knowing the future is in good hands.

A special thanks to Gene, our Park President, for his leadership and support during my time as Board Chair. This was my second opportunity to work with Gene in a board setting.

Season Departure Checklist

When you're departing for the season we recommend the following top ten tips:

1. **Check and update your contact information.** Login to Member Web Access and update your summer and winter mailing address and phone numbers if needed. Because your email address is your login, you'll need to contact Member Service to change email address(s).
2. **Put a hold on your stickers.** Due to missed stickers, we will not clear the hold field in the database this year. If you know you want your stickers held next spring, please tell us now. If you have frequent trouble with mail or are afraid you'll miss your mailed stickers, it is important to place a hold on them. They will then be waiting for you at the main gate.
3. **Submit your mail forwarding request.** If you have a Sandy Pines mailbox, submit your forwarding request 3-4 weeks before you depart. You can begin forwarding at any date but it may take up to a month for it to

PARK & GARDEN NEWS

It is hard to believe that we are approaching the end of the 2019 season. It seems like yesterday that we were moving all of the product for the store into the new location. The new store has been a great addition, and has proved to be good for all concerned. Last year I was writing about members not know we still had bulk product and propane. Now this year, our sales have increased for both bulk products and propane.

We had record numbers of water softeners provided to the members this year and even with the slow start (because of weather) the marina and rental watercraft had a good year. We will continue to rent watercraft through September 28th depending on the weather. You will need to come to the rental office or call and leave a voice mail for rentals, except for Saturday afternoons. We will only be open on Saturdays during the month of September through the 28th.

Golf Carts will be available through September 28th but you need to call 48 hours in advance or rent with the online system. The office is no longer open with regular hours after the 9th so you will need to use the voicemail system or the online rental software.

Park and Garden will close for weekly business on September 8th and will only be open on Friday and Saturday during the rest of September. We close on September 28th for the season.

We will have RV Antifreeze and Leaf Bags for your needs during September.

To those of you who need your boat removed from the lake before leaving, you can schedule boat removal for September. All boats that are removed by Park and Garden must be done before September

28th. If you need it after September it is an additional \$20. Be sure to call and get your time reserved for removal.

We will be busy during September picking up water softeners for those of you that are closing up before October 15th. In order to get a discount on next year's softener, be sure to stop by the Park and Garden and fill out your contract for 2020, and schedule the date for the pick-up of your softener. Next year will be the 8th year of the Softener program through the Park and Garden. We have not raised prices in those 8 years, but the time has come, as our supplier is raising our cost for the tanks. The 2020 season will be \$180 for the season unless you put your order in before October 15th.

If you order before you leave for the season, you will receive a \$20 discount. The cost of install will be the same as it has been.

If you are returning your softener, please drop it off by the PROPANE tank by the bullpen gate. Mark your tank with duct tape and include your site number so I can give you credit for the return.

Thank you for using the softener service for the 2019 season and be sure to sign up for the 2020 season before you leave for the year. You can sign up at the Park and Garden or get the form on the online web and at member service. It helps us to know if you are closing your site before October, so we can get over and pick up your softener. We have over 300 to pick up this year. Thank you!

The water in the Park will be turned off on October 15th. When we winterize the main water supply, we unhook all of the hoses at the main riser. Please make sure that your hoses are

correctly marked for winterizing your trailer and also for hook up in the spring.

It is important that you blow out the water line all the way to the riser when your site gets winterized.

As always, we have a long list of improvements to work on during the off-season months. I will keep you posted on our progress as we move forward.

take effect. Members are often caught off guard, especially in spring, with missed bills because they are stuck in forwarding limbo. Please call if you think you are missing your bills, as we cannot credit finance charges due to lack of selected mail service changes. If you keep your mailbox from season to season you do not have to return the keys unless you'd rather not keep track of them. If you wish, we can hold them at Member Service.

4. **Order your winterization.** If you've been winterized by us in the past, we'll e-mail or mail your order form, which you can complete and return to us. Confirmation of winterization is not guaranteed by your receipt of the form. You must complete, sign and return the form via the appropriate dates. We will attempt to send you an email confirmation after your winterization is complete. Winterization departure dates on or before September 30th start at \$90 and your keys must be in the office by September 30th to get the discount. Winterization forms received on or after October 1st start at \$110. The latest departure date is October 15th. We are not able to winterize trailers that have hot water heaters located on their porch or trailers or that share a water line. We can only accommodate 500 winterization orders. Make sure you leave a set of keys at Member Service.
5. **Unplug your modem and router.** Even though you may be turning off power to your trailer, it is recommended to unplug electronic devices to avoid power surges. If you are going to be visiting during the winter you can use the devices as service is not shut off to the park; however if something happens to internet or cable service, it is only supported by Spectrum between April 15th and

October 15th. If you are keeping internet from season to season, please keep your modem at your site.

6. **Plan and order your last pump-out of the season.** Each year members contact us after pump-outs are complete and are stuck without options as no one else pumps out trailers in the park. Monday, October 14th through Friday, October 18th is the final week of normal pump-outs for the season. We do offer two final emergency pump-outs on Wednesday, October 23rd and 30th.
7. **Tidy Up.** Spring cleanup can be easier if you clean up a little in the fall. Our Registered Contractors List online at www.sandypines.com/members lists businesses that can help. Registered Contractors are insured, know the park, and have their own access cards so you do not have to sign them in as guests.
8. **Remove your boats and floating docks.** Boats must be removed by November 1, 2019. If you installed a floating dock in your boat stake position, be sure to remove it. While not required, it is highly recommended to remove the dock to eliminate damage from freeze/thaw cycles.
9. **Plan ahead for Annual Dues & Quarterly Electric Payments.** Annual dues & quarterly electric/unit tax will be billed on October 1st and due on October 25th. We do offer a six month payment plan that **applies only to dues and assessments.** If you opt in to the plan, please understand **the monthly installment amount does not include previous balances, new account charges, or quarterly electric and state unit taxes billed during the payment plan term.** Those charges would be in addition to the installment amount. You can put money on your account in advance and carry a credit to help minimize the amount due in October.

ACCOUNTING UPDATES

BY KIMBERLY WILLIAMS

The 2019 Season has been a great year both financially and recreationally.

The financial statements for both Sandy Pines and Lake Monterey Golf Course have maintained positive increases from prior year and appear financially stable in preparation for the more costly months ahead. Please review the recording of the August Board of Directors meeting and Annual Update BOD Meeting for more detailed information.

FY2020 Budget Review:

In August we presented the final Operational and Capital budgets for the 2019-2020 fiscal year to the Finance Committee and Board of Directors for review and approval. These budgets have been posted on the website under Finance.

Specific items to note in regards to the budget focus for the 2019-2020 season include;

- An increase of \$24 to operational dues per the Bylaws in relation to an increase proportionate to the CPI Index 12 month increase for the Midwest Region as of March 2019.
- Operational dues without any pass-through amounts (i.e. Capital Dues, Golf Course Assessment or Cable TV) cover 38% of operational expenses. The re-

maining expenses are funding through other revenue streams within the park.

- The 2019-2020 budget reflects a \$99k pick up with net expense on the bottom line budget to maintain the park's not-for-profit focus of a balanced budget.
- The park in addition continues to focus on maintaining a 180 day cash reserve, with investment decisions adding to park assets and overall value of the park.
- The 2019-2020 fee increases include; Boat Dock (\$500), Contractor Fee (\$200), Delinquent Account Reactivation Fee per card (\$35), Guest Pass 1 Day (\$5), Guest Pass 1 Day-Security Assisted (\$7)

Upcoming Dues and Assessments:

You will find your 2019-2020 Dues and Assessments, total of \$1,882 billed on your September statement and mailed on October 1st. Please refer to the outline within the Footprints and on the Sandy Pines webpage for the cost breakdown. Payment will be due October 25th. Sandy Pines does provide an option for six monthly installment payments to pay the dues, capital contributions, cable and assessments only in the amount of \$325.46 (October through March). The payment plan does not include any other fees and charges billed to your account each month. Failure to make pay-

ments within the payment schedule, will result in the members' ineligibility of using the installment plan and your remaining balance will be due in full the month following a missed monthly installment payment. Continued unpaid balances can result in membership termination.

Many questions have arose regarding the current status of the Senior Adult group here at Sandy Pines. While this group is very important


Fall winter weather:

place a candidate or proposal sign on their site.

e. Election signs may be displayed on the member's personal property. Personal property is the member's shed, camping unit, porch enclosure, or vehicle parked on the member's site.

f. An election sign may be placed on a member's personal auto or golf cart, provided sign does not obstruct the vision of the driver.

C. Election Flyers:

1. During elections, persons may discuss issues with members present on their sites. Persons may hand out flyers to those persons present on their site.

2. Persons may hand out flyers for elections in public places, such as Flea Markets or at a gate on the street.

3. Persons cannot hand out flyers or make available political flyers in Park buildings, leave flyers on vehicles or at a membership site, when members are not present.

4. In leased buildings, however, the lessee may determine what literature may be given out or displayed inside their establishment.

5. Individuals running for the Board of Directors, or those campaigning either for or against a proposal, may display signs in the Fourth of July parade.

D. All Other types of signs:

1. All other signs must have consent from the Park President or Park Inspector to be displayed.

E. Identification requirement at voting polls:

Voters will be required to provide a State issued photo ID to the election officials at the polls.

Member Guests and speed rules:

For members who are having guests who are not familiar with the Park and rules, please advise your guests of the 10 mph speed limit prior to their entry into the Park.

Mag Cards:

For persons with a magnetic strip access card, if you are having issues with the card such as having to swipe multiple times, please stop at the Public Safety Office at the Main Gate and we will be happy to check the card and attempt to diagnose the problem.

New ByLaw Language: Shall Article II, Section 7, Death of a Member of the Bylaws be amended in its entirety to read as follows:

Section 7, Death of a Member - Transfer Rights: Subject to the qualifications established in Article 11, Section 1, the membership of a deceased member may be transferred by testamentary disposition, **trust instrument**, or intestate succession. Upon the death of one of the joint tenants, Sandy Pines shall recognize the surviving joint tenant as the member, notwithstanding testamentary disposition of the membership by the deceased joint tenant.

Should more than two (2) individuals claim the deceased member's membership, then the Board shall refuse to transfer the membership until it receives an opinion of legal counsel identifying the individual entitled to the membership. If legal counsel is unable to determine who is entitled to the membership, then the Board shall have the option of terminating the membership by payment to the deceased member's estate of an amount equal to the current assessed value of the membership less currently owed annual membership dues, special assessments and capital assessments, utilities, or other charges.

**At the annual election held August 15, 2015, the membership approved a ten year annual golf course assessment to be used for golf course operations and capital assessments.

***At the annual election held August 19, 2017, the membership approved a ten year annual Capital Reserve Fund assessment; which shall be dedicated to capital expenditures, as listed and reviewed annually, on the 10-year Capital budget estimate, beginning in fiscal year 2017/18.
