RESOLUTION NO. 062124A

Resolution to Accept the Investment Policy to Add an Interest-Bearing Money Market Account

WHEREAS, Article VIII, Section 6, Item b. provides that the Bylaws of Sandy Pines "designate, by resolution, the banking institution(s) as a depository for the funds of Sandy Pines, the officers, agents, or employees authorized to execute contracts and other instruments, including withdrawals on behalf of Sandy Pines."

WHEREAS, the Finance Committee has reviewed and recommended the addition of an Interest-Bearing Money Market account for the best use of Sandy Pines Operational Funds.

WHEREAS, the Board of Directors of Sandy Pines Wilderness Trails, Inc., believes it is necessary to maintain the guidelines of the Investment Policy to add an Interest-Bearing Money Market Account.

NOW THEREFORE, BE IT RESOLVED that the Board of Directors of Sandy Pines Wilderness Trails, Inc. does hereby approve the following action to open an Interest-Bearing Money Market Account to be maintained only to accrue interest and used along with the Operational Checking Account.

This account will have two signers: Park President, Jeff Sweitzer and Chief Financial Officer, Kimberly Williams.

The account transfer from the Operational Checking Account to the Interest-Bearing Money Market Account must leave at least the amount equal to the current balance of outstanding checks plus the current week's accounts payable balance in the Operational Checking Account.

It is the responsibility of the Park President and Chief Financial Officer to ensure the amount of funds in the Operational Checking Account and Interest-Bearing Money Market Account uphold the guidelines of the Investment Policy.

RESOLUTION NO. 062124D Resolution to Acquire Contiguous Real Property

WHEREAS, the By-Laws of Sandy Pines Wilderness Trails, Inc. Article IV, Section 1 gives the Board of Directors the power to "purchase property if all of the following conditions are met;

- (A) Sandy Pines has sufficient capital resources to acquire the property without taking on a debt or a mortgage; and
- (B) The proposed property acquisition is contiguous to the property currently owned by Sandy Pines. The members shall be informed of any property acquisition via the next schedule communication with the members.

WHEREAS, a Property located at 2738 138th Avenue, Hopkins, MI (the "Property") was recently listed for sale, or is about to be listed for sale. The Board of Directors of Sandy Pines Wilderness Trails, Inc., by itself and as the sole member of Lake Monterey Golf Course, LLC ("Sandy Pines"), wishes to make an offer on the Property.

WHEREAS, Sandy Pines has sufficient capital resources to acquire the Property without taking on debt or a mortgage and the acquisition of the Property is contiguous with the property currently owned by Sandy Pines.

NOW THEREFORE, BE IT RESOLVED that the Board of Directors of Sandy Pines Wilderness Trails, Inc. does hereby approve the following offer ("the Offer") to be made on the Property:

So long as the conditions of Article IV, Section 1 of the Sandy Pines' Bylaws are met, an offer shall be made to acquire the Property, with an accelerator clause that increases the purchase price by \$1,000 over the highest offer, with a limit to be determined by the Park President within the Bylaw parameters.

Be It Resolved, that the Board of Directors of Sandy Pines Wilderness Trails, Inc. does hereby approve the Offer to be made and authorizes Jeff Sweitzer. Park President, to execute and deliver the Offer referred to in this Decolution and to perform all other acts and obligations contamplated barein

BOARD OF DIRECTORS UPDATE

(The following scenario is not based on current reality. It is a fantasy....or a nightmare as it were. More of an "imagine if". Read and draw your own conclusions).

It's April 2027 and I'm ready for that first trip to the Pines. You can almost taste the excitement! Seemed weird the maintenance gate wasn't open but, oh well, a simple turn onto 28th and off to the main gate we go. But when I get close, there are lots of cars on the road unable to get into the Park. Lots of confused folks with lots of unanswered questions.

I finally track down a PSO. "What's going on?" He replied, "Park's closed, probably for the season. Might as well turn around and go home." "Closed", I replied, "but that's not possible. The misses and I have a full carload and we're ready for our first weekend!" Probably a little more agitated than I should've been. "Guess I'll have to contact the Park President and get to the bottom of this."

And so I called him. And wished I hadn't. "It's bad, Paul", he said. "With pressure from the township and others, the State has decided to revoke our campground status." So what, I thought. It's still our happy place, right? No big deal, just change the name on the sign and we're good. "It's not quite that simple, Paul. We're now considered a mobile home park. Because we'll now be open year-round, no more holding tanks and pump outs. No more risers. That means all new underground sewer and water lines. "That's why were closed, because of all the construction." Wonder what that's going to cost? As if he could read my mind, he said, "depending on the final bill, the guess is each member site will have to pay between five and ten thousand dollars." Survivable, but still a yikes.

"And that's just the beginning", he continued. "The county and township may now proceed with assessing the Park for tax purposes. You can forget that miniscule \$9.50/quarter the township collected up until last year. Using a basic home value of \$100,000 and current rate of 35 mils, that would result in an annual tax bill of about \$1700. Per site. Some would pay more, some less." Gulp. "And that's not all," he continued. "That's assuming the homestead rate. Which none of us can claim here as it's our second home. So it'll be even higher than that." As we say at the 7-11, big gulp.

"What about our dues and all that extra money we have laying around? That should at least help right?" My plea fell on deaf ears. "It gets worse. We earn a lot of revenue via campsites and seasonals. With us no longer being a campground, we can kiss that goodbye. As well as a lot of our rental carts which are largely used by campers. Also, because we're now open 24/7/365, that means more personnel. We'll also have extra costs for snow removal. The final numbers haven't been hashed out but, suffice to say, costs to every member will go up considerably. Every year."

"But how could this happen? I remember reading about a 1998 case where the State Tax Tribunal ruled in favor of Sandy Pines in a similar situation. The State and Township came after us but we prevailed. Shouldn't the same have happened now?" He replied, "We won that and were able to protect our

campground status by proving that we met all requirements and had steps in place to continue to do so. Sadly, we've all become lax and allowed rules to be bent or overlooked. Remember back in 2024-2025 when we warned members about staying compliant? There was a lot of consternation and heartache but most toed the line. A handful chose not to, and today, because of that, we're all paying the maximum penalty."

I ended the call completely deflated. Now what am I going to do? What are we going to do? SP has quickly morphed into an unhappy place. Many will be forced to sell. But who's going to pay upwards of \$300K to live in a mobile home park? Property values will plummet, lots and units will go unkempt, making it even more unlikely for a prospective buyer to consider this a desirable place to live. This stinks.

Is this a probability? Who knows? Could it happen? You're kidding yourself if you think otherwise. This isn't scare tactics, it's a reality check, people. The Park has a pretty good feel for what needs to be done going forward. Going backward, it has not yet been determined about those units having modifications already in place that are causing concern. Stay tuned to trusted news sources for the latest. Questions? I'll bet you have a few.

FINANCE & ACCOUNTING NEWS

The most recent May 2024 financial statements for both Sandy Pines Wilderness Trails and Lake Monterey Golf Course have been approved and posted on the Finance page under www.sandypines.com.

SPWT

- Operational cash is \$1 million down from the prior year; we are waiting on a few additional invoices to finish the payoff of the Phase 2 pool. When the project is complete and all invoices paid, the asset replacement cash will refund the operations cash balance.
- The Schwab Investment activity account is up \$42k from the prior year, a 2.5% gain.
- The Admin and Board of Directors have been looking for ways to capitalize on the Days Cash on Hand and through an approved resolution, Admin has transferred with the same bank; operations cash reserves from the checking account to a liquid interest-bearing money market account earning 4.2%. This is easily transferrable back and forth through the checking and money market account.
- Member A/R is down as we typically see at this time of the year.
- Acquisitions are near finished for the current season so you won't see major changes in these accounts through the remainder of the year.
- Current liabilities are \$462k with a \$28M overall Total Assets; which is a phenomenal margin.
- Admin Misc there are no significant changes. We will see an increase in Inspection Income as we work in that area. Overall on a consolidated basis you will see an increase in payroll on the May YTD statements since May included 3 payroll cycles rather than the typical 2.
- Maintenance Doing a great job maintaining their balance and budget.
- Public Safety and Security no significant changes
- \bullet Recreation no major changes as the season is just starting.
- Resort no significant changes in the month of May, except the regular monthly Cable Bill, depreciation and a \$20k gain in the month of May.

- Lease this department will have minimal activity with the only activity is through the Beauty Shop, BBlessed and food trucks.
- Park and Garden off to a good start in the season and moving previous activity of the Country Store and Country Café to Retail. Current Net Income for P&G is \$31.5k vs \$18.5k, up \$13k due to less expenses through this season.
- Golf Rental expenses are showing an extra lease payment for the golf carts in the month of May. The 2nd check posted on 5/31 for \$16k, the last day of the month. Without this extra lease payment, overall net income would be \$4k higher.
- Retail Center showing the start-up of the Country Store \$17k, Country Café \$9k and Dairy Dip \$21k. The current month of May shows a large start up of COGS and expense for the preparation of the season as well.
- Sales is experiencing a \$47k increase in Sales through the Park and \$7k increase in camping, which expenses similar to prior year activity.

LMGC

- Operational Cash is up \$234k and mostly impacted by the payoff of A/R during the month.
- Asset cash is up \$14k, and will replenish operations cash at the end of the season for all capitalized projects.
- Net Income is up \$16k overall from prior year.
- Memberships is up \$2,650
- Public green fees is up approx. \$7k
- Member green fees are up \$7.4k
- Food is down, net cogs is \$1,539
- Beer and wine is up, net cogs \$1,274
- Merchandise is up, net cogs \$7.7k
- Salaries shows an increase in payroll on the May YTD statements since May included 3 payroll.
- Overall expense is in line with prior year.

Dam rehabilitation update:

In previous newsletter articles I have tried to keep you informed of the progress of the Dam project. It has been over six months since piping along the 54-year-old Corrugated pipe was discovered. Fortunately, the piping has not increased in flow of water or in flow of sediment. During this time engineers have developed the final drawings for the Dam and a coffer dam design to hold back the water back during the project. The Allegan County Drain Commission has posted the project on their web site for contractors to review and bid on the project.

The project will be advertised June 4th. On June 18th the contractors will be on site to look over the project, review the area, ask the engineers questions about design, construction and materials. Sealed bids will be submitted to the Drain Commission by 10:00am on July 2nd, 2024. The sealed bids will be opened at Allegan County Drain Commission office on July 2 at 10:00am. After the bids are opened The Drain

Commission, Spicer Group Engineers, Sandy Pines, and the Dam Safety Unit will meet with the contractor to discuss the project.

With supply chain issues the Allegan County Drain Commission has already contacted the concrete culvert vendor to ensure we have the box culverts at time of construction (around Sept. 9th 2024).

The Dam Risk Reduction Grant is being finalized by the State Dam Safety Unit. Sandy Pines members should be very thankful for the award of up to \$723,600. The award greatly reduces the Sandy Pines and your out-of-pocket expenses.

The Michigan Dam Safety Unit has been very involved and supportive from the onset of awareness of the piping issue to the present. We should be thankful for their guidance and support. Supportive parties have been Allegan Emergency Management, Allegan County Drain Commission, the Allegan County Road Commission, Monterey Township, Salem Township, Spicer Group Engineers and the Sandy Pines management team. Each of these entities has played and continue to play a role in this project, moving forward and being successful. Sandy Pines is grateful for their involvement, attendance of meetings and their knowledge and commitment to our community. .

Sandy Pines will have a commitment of at least \$361,600. Estimates by the engineering firm for the project is over one million dollars. Competitive bidding may lessen the expense but with inflation and supply chain issues it is unknown whether the cost will exceed our estimates.

People always have the what ifs. What if the project only costs \$800,000 and is less than the engineers estimate? Sandy Pines is committed to \$361,600 and the States amount would be reduced. What if the project bids exceed the combined awarded grant and Sandy Pines commitment of funds of \$361,600? Project costs that exceed the State grant funding and Sandy Pines commitment of funds would be the responsibility of Sandy Pines.

In conclusion the next major steps are contractors doing a walk through of the work site, contractors submitting a bid to the Allegan County Drain Commission, the opening of bids and selection of a contractor by Allegan County Drain Commission, Sandy Pines and the Spicer Group Engineers. In the next news article hopefully we can share the awarded contractor and the bid price of the selected contractor.

FEMA Storm Shelter CC#1:

As indicated in previous articles Salem Township and Sandy Pines were awarded a FEMA grant of \$917,332.28 to build a tornado Saferoom in phase 1 to replace CC#1.

Salem Township has posted the architect's position and a description of the project on their web site. The architect position will be posted for at least 30 days as per the Salem Township procurement policy. Architect qualifications will be received up to July 2, 2024, at 11:00am. Opening of architect and the selection process begins July 9th, 2024, at the 7:00pm Salem Township Board meeting. Posted information can be found on Salem Township's web site.

After selection of the architect the Saferoom committee will meet with the architect. The design will be discussed, and the architect will work on the design and a bid package for contractors interested in the project. Once the bid package is developed the posting of the project will be advertised for 30 days as per the township's procurement policy.

Fall is approaching fast and as indicated above procurement is a couple of months and design also adds at least another month bringing us into the fall as a start date. The intent of the project is to construct the building in the off season and open prior to Memorial Day.
