

**RESOLUTION NO. 071924A**  
**Resolution to Amend Rulebook/Handbook**

**WHEREAS**, the By Laws of Sandy Pines Wilderness Trails, Inc. Article VIII, Section 6(e) gives the Board of Directors the power to “adopt, amend, rescind, and repeal rules and regulations relating to the use of Sandy Pines property and the conduct of its members and their guests.”

**WHEREAS**, Rules Section XIII. Watercraft Regulations Sub Section F. Watercraft Rules and Regulations Item 19h currently provides

Item 19. Water Skiing, Pulling Tubers and Wake Surfing:

h. Usage of the ballast function or any alteration to any boat for the purpose of producing waves for any activity is prohibited. All wake surfing is NOT permitted.

**WHEREAS**, the Board of Directors, for the health, safety and welfare of Sandy Pines, believes it is in the best interests of Sandy Pines to amend and clarify the Rules and Regulations.

**NOW THEREFORE, BE IT RESOLVED** that the Board of Directors of Sandy Pines Wilderness Trails, Inc. does hereby approve the following amendments and additions to the Rules and Regulations relating to Section XIII. Watercraft Regulations Sub Section F. Watercraft Rules and Regulations Item 19h (located on Page 29 of the Sandy Pines Rules, Regulations and Bylaws Handbook):

**Item 19. Water Skiing, Pulling Tubers, Wake Surfing and Wake Foiling**

h. Usage of the ballast function, any boat manufacturer feature or any alteration to any boat for the purpose of producing waves for any activity is prohibited. All wake surfing and foiling is NOT permitted.

Be It Resolved, that the Board of Directors of Sandy Pines Wilderness Trails, Inc. does hereby approve the above Resolution.
