Snow Load:

In the past, we have had some porch enclosure roofs damaged from snow load. Some trailer roofs have also been damaged by snow load. Please remember to check, or have a friend check, the amount of snow on your porch enclosure roofs. Sandy Pines commonly has lake effect snow. As a result, the Park normally has more snow than inland areas.

The Ranger Station will have phone numbers of person(s) that clean the snow off roofs, so please contact them for that information.

The Ranger staff has also noticed golf cart roofs that are stored outside bowing from the accumulation of snow. Don't forget to check your golf cart roofs if stored outside.

Lake Ice:

As the days begin to get colder, ice will form on the lake. Please use great caution when going out on the ice. A general guideline of four inches of new, clear ice is the minimum thickness for travel on foot. A general guideline of five inches of ice is required for snowmobiles. Remember, these are general guidelines and many factors besides thickness determine the safety of ice. The lake does have a constant current and under water springs. These can make the ice weaker in various areas. Don't risk your life to get out on the lake to fish or snowmobile. The water is very cold and hypothermia can place your life at risk, should you fall through the ice.

Snowmobiles Usage of the Park:

Please operate snowmobiles on Park roadways and abide by the 10 mph speed limit. In the past, persons have been severely injured in the Park and local area, due to speed. Operators must have a State driver's license or State issued Snowmobile Safety Certificate.

Please do not cut across another member's site or drive in green areas. If driving along the lake, be careful not to run into a dock or boat stake along the shore.

Snowmobiles trails are nearby Sandy Pines and connect with the nature trails. Local trail maps are available at the Ranger Station and local retailers.


Park Roads and Winter Conditions:

Maintenance does a very good job of plowing the roadways in the winter, however; winter storms and lake effect can cause park roadways to be filled with snow. The banks along the road may also be high and impassable by autos.

If you decide to come out to the Park, be aware of the weather forecast and contact the Ranger Station to check current conditions. Lake effect snow can accumulate quickly and blowing snow can fill roadways. Maintenance is not in the Park 24 hrs per day. If the weather changes, you may want to decide to leave before heavy snow or snow storms, or plan ahead to stay in the Park until roadways are cleared. It can be a few days after severe storms that county roadways or Park roadways are cleared.

Please do not park in the roadways within the Park. This prevents our plow trucks from plowing streets. If you plan to come out to Sandy Pines, plan to clear your driveway, park at the nearest convenience center, at the core parking lot or Adult Recreation Center parking lot.

Plan ahead if you have health conditions that will prevent you from walking distances, or prevent you from shoveling snow. Don't over exert yourself. If you do enter the Park and become stuck, please be aware that Park vehicles will not pull you out of the snow. You will have to contact a local tow service to free your vehicle.



Comments, Suggestions and Questions from Members

This is the second time we have included this new article, with the first being in the September issue. I will attempt to use actual comments, suggestions and questions that were submitted on paper where I can or I will quote those that have come to be verbally as best as I can recall them. Thank you goes to all of those who have submitted the following:

Comment:

The drain fields where all the Member holding tanks are dumped cannot use odor control chemicals that contain formaldehyde. Campgrounds with drainfields do not allow these chemicals to be used, and Sandy Pines should do the same. At the last look, Sandy Pines was still selling these chemicals in Park and Garden.

Response:

The Member is exactly correct. Formaldehyde kills bacteria (also called bugs). In doing so, these products inhibit, or prevent, the waste from breaking down as it does in our sewer systems at home. Consequently our waste becomes extremely toxic to the septic system and potentially, to the ground water. Our septic system behind the ball field failed in June of 2012, in part, due to the high toxicity of our waste. Since that time (while we were researching septic options) we have been having our waste hauled to Allegan Wastewater Treatment Plant, and as such, the requirement for non-formaldehyde chemicals was not a factor. As of September, 2013, Sandy Pines was given DEQ approval for a newly engineered septic system and drain field in the same location. Our new system will be operational by April 15, 2014. So, as stated in the comment above, Sandy Pines will not allow formaldehyde based odor abatement products to be used in holding tanks, beginning April 15, 2014, and for the foreseeable future. Park and Garden will no longer carry unapproved odor abatement chemicals, so if you want to be certain of what you can use, please stop by Park and Garden to ask about them or purchase them. We ask that you do your part to comply with this new policy to avoid another expensive septic failure, or create a situation where the DEQ will require us to do ground water testing in the future. Such requirements may/could lead to much greater costs.

Question:

Can we have a \$10 Kayak fee?

Answer:

Yes. As of 2014, a member that is not holding a boat stake with a paddleboat, kayak or canoe, will not be required to have a Michigan Watercraft Registration on it. If you are not holding a boat stake, you will purchase a sticker that will be used for golf carts, canoes, kayaks and paddle boats for \$12.

Question:

Can we get a BIG hot tub for the adult pool?

Answer:

If you have heard me speak in the past, or have seen things that I have written about our State of Finances here at Sandy Pines, you are familiar with the point that I have made repeatedly. That being; Sandy Pines is financially healthy, however, it is imperative for us to know and to be prepared, (#1) to maintain the Park and its amenities we have. This has been at the top of my list from day one of my tenure here, beginning in December of 2012. (#2) How will we fund the care and keeping of this great Park to maintain an acceptable level of its condition?

Last year, we did a 10 year Repair and Replacement report that was presented at the annual meeting and is now posted online on our website. In it you will notice that we estimate that over the next 10 years, we will need to repair or replace items at an estimated cost of \$8.3 million dollars. This is to maintain our assets. It does not include adding any new amenities, such as hot tubs, hockey rinks, a new family indoor pool, etc, etc. (this list is long)

Approximately 50% of the needed funds to maintain the condition of the Park will come from dues. As you look at the breakdown of your dues, you will see that Cable TV, Golf Course Assessment and Capital replacement are three areas that have amounts designated to them, other than Operations. The Capital Replacement funds for 2014 amount to \$200 of our dues or \$425,400. With a 10 year estimate of \$8.3 million needed, this is equal to \$830,000 per year, meaning there will be a shortfall of approximately \$405,000 a year. It is my job to find revenue to make up that difference, and until we do, it's unlikely that we'll be adding many amenities. That is, unless there is a request for a ballot proposal brought to the Board that would ask the Membership to vote for a special assessment to fund any new amenities.

With that said, please do not fear the future! We are making plans, seeking our options, and we are committed to research them as best we can. Budgeting for Sandy Pines is not really different than your household budget, just bigger numbers. However, we must use our resources responsibly as we look ahead to differentiate our needs from our wants.

Question:

Can we require skirting on all RV units in the Park?

Answer:

This question has been debated this past summer by the Rules Committee. I was present for some of the debate, and it's apparent

that there are good arguments on both sides of the issue. I would suggest that you check out the new Rule Handbook that is now available online on our website or request a printed version from our office (\$2) to determine if the rule pertaining to your question has been revised. If not, I would suggest that you have conversation with the Rules Committee Chairman, Stan Robbins.

Comment:

A few days ago (*this was brought to me in September*) as I was walking on the main beach, I saw five dogs with their Masters on the beach. Suggestion: enforce the ruling that says no dogs can be on any beach, and also no dogs can be in the Flea Market area. Put permanent signs up!

Answer:

It is true that our rules state that no pets are allowed in the swimming areas, buildings or at the Flea Market. The exception being that service dogs are always permitted. Late this fall we posted 'No Pet' signs on the entry doors of all of our buildings, however we did not post any new signs in the swimming areas, and I thank you for the mention. I will respond accordingly.

Comment:

Some Rangers drive too fast! 20mph.

Response:

So noted. Certainly, if they have been called to get to a site immediately, they will speed, as do safety officers on our roadways. However, a reminder to all of us to have a greater awareness of our speed in the Park is a good thing. Thank you.

Question:

Why isn't there a scale in the fitness room?

Answer:

Probably for the same reason there is no remote for the TV.... They get stolen! We'll check out some options in the off season to see if we can get a more secure situation for both of these items.

Question:

Why can't we get more chase lounges on the adult pool area?

Answer:

Mary Applehof, (our new Recreation Administrator), will be ordering 24 new lounge chairs in a different color than the green ones we now have. The color difference will help in minimizing, and identifying, which chairs belong on the upper level and which belong in the adult area. Hopefully this will be benefit to everyone.

Question:

Can there be rules for the Memorial Garden on the main road (from Phase 4 to 5)? The placement of plastic flowers and plaques make our Park look tacky and creepy. Markings should be authorized by the Park that would not allow plastic flowers and memorials at ground level only. What will it look like in 10 years?

Answer:

I am confident that this area will look awesome in 10 years, (likely in less time than that!). Our new Building and Grounds Committee, chaired by Mike Young, is focusing on this area for improvements and beautification. Many of the ideas they are contemplating relate directly to your concerns. I would think that prior to the end of the 2014 season, we will see recommendations go to the Board for approval of policies that will improve this area immediately and in the future.

Although they are all requested out of concern of safety, and in many cases there are effectively rules here at Sandy Pines, however, it's hard to imagine what our Park would look like if these were all posted wherever they would be applicable;

NO PETS ALLOWED

NO PARKING ON THE GRASS

NO TEXTING WHILE DRIVING A CAR OR CART

DO NOT PLAY ON THE BEARS

NO PETS ON THE BEACH OR IN THE WATER

NO PETS IN THE FLEA MARKET AREA

NO GOLF CARTS ALLOWED (SPECIFICALLY IN AREAS THAT HAVE HAD A FENCE REMOVED BY KIDS TO GAIN ACCESS TO AN AREA THEY ARE NOT ALLOWED)

NO JOY RIDING IN THIS AREA

NO OVERNIGHT PARKING

BIKES MUST OBEY ALL TRAFFIC RULES

NO WAKE ZONE

STAY 100 FEET FROM THE SHORE AND DOCKS

NO JUMPING OFF THE CC ROOFS

NO CLIMBING TO THE TOP OF THE SWING SETS

NO CARTS ON THE BEACH

Follow up on the answers given in the September Footprint article pertaining to the new photo ID card.

Here is a list of some of the top reasons we are implementing the Photo ID card:

- 1) Some Members have given their cards to others so they can receive free golf.
- 2) Some Members have given their cards to others to gain access to the Park.
- 3) At times, Members lose their cards. Photo ID prevents lost cards from being used by others.
- 4) Often, Members arrive at the Main gate without their card. A quick look at their account will now allow the Rangers to see a file photo of that person to confirm they are who they say they are.
- 5) A data base with names and a photo is a true means to determine the identity of persons attempting entry or use of amenities.
- 6) The loaning of membership cards costs us all revenue, increases security risks and may limit the use of park amenities to Members if/when non-members are using them.
- 7) The new card will provide positive ID when/if someone wants to charge their account, in our office or at a flea market.
- 8) A driver's license will not be required to vote if a Member has their photo ID to show.
- 9) Photo ID is less costly to implement than BioMetric identity methods.

originally presented to pay for paving cart paths for both the front and back... The front was never done and the back should have been paid for years ago... This was the original proposal and should never have been permanent.

I think every member/associate member should either have picture ID or have to show or swipe card with picture ID to keep members from sharing their cards with non-member/associates.

I love our golf course. At first I wasn't happy about the assessment that I had to pay. But now that it's part of my dues, I have golfed a lot more than I had in the past. It's such a sensitive subject, and one that I am sure is

going to be a heavy burden for everyone to figure out.

I think it is important to realize that the "backbone" of a golf course's success lies with its most loyal users: Enthusiastic golfers who use the course often. I am not in favor of the assessment. I don't think Associates should get free golf since they don't pay anything themselves. Just members should get free golf.

Enjoyed the time playing with my children on this course. If I had to pay, I would not play.

I think the course is a huge asset to the Park. I also think it should be priced reasonable for the members and a better price for them than the public, in general, if it remains a public course. Other golf courses seem to be able to support themselves. Maybe instead of charging all the members, you could sell memberships to the people who use it a lot and want to buy one. Then they could get discounts on their fees.

I don't think the golf course should be supported by our dues. I do not like the idea of the golf course assessment was not voted on by the membership.

Outdoor Storage Update

As you have probably heard, the Outdoor Storage area is no longer going to be available going forward for the foreseeable future. The current outdoor storage is located on a drain field which created damage, resulting in the need to replace it this fall.

As of September 10, 2013, you are required to move your items in the Outdoor Storage area to the Chapel (south side of parking lot near the tree line that runs along the Marina side), or you may store them at your own site. If you are not sure where to park your item at the Chapel, please contact the Inspector at 616-896-7286, Maintenance, 616-896-8317 or the Admin Office 616-896-8315.

In the spring of 2014, you must make arrangements to have your items removed from the Chapel location no later than May 19. You will have to make other arrangements for storage, either inside Sandy Pines as space in the bullpen permits, outside the Park, or on your site. Check with Member Services for bullpen availability and pricing after April 1, 2014.

There will be a fee assessed, should our Maintenance Department be required to relocate your item for you. We apologize for any inconvenience, but the drain field replacement has become necessary.
