Boat Stakes and Water stickers:

Members who have, or will have expired state registrations for their boats, have until June 1st to get an updated copy of the registration to Member Service. You can email a copy to memberservice@sandypines.com or fax to 616-896-7409. You will not receive a boat sticker in April, and risk losing your boat stake, unless we have the proper paperwork by June 1st.

Non-motorized Boats:

The Board of Directors amended the Watercraft Regulations regarding non-motorized boats effective 1/1/2014. Canoes, kayaks, paddleboats and single or two person sailboats that do not park at a boat stake or dock space, will no longer be required to register that boat with the State. You will be required to have a Sandy Pines non-motorized land sticker and display your site number, at least three inches high, and highly visible, on the right rear corner of the vessel for identification. The cost of the non-motorized land stickers for 2014 will be \$12.

Remember, if you need permits, both Sandy Pines and Township, they are available online, or you can stop by the Ranger Station and pick up the forms you need. When filling out the permit forms, be sure to list the name of the contractor, if you are using one. If no contractor is listed on the form, then you are saying you will be doing the work yourself. If any issues arise, the homeowner will need to make the necessary corrections. We have had a few issues when the Township does their inspections, caused by members pulling electric permits and having unlicensed people do the work.

Please take time to read and understand the updated Handbook that is online, for new updates in the Permit Section. Please feel free to get in touch with me on any concerns you might have.

At the present time, we have two trips scheduled this summer, with Rog Grinwis, Signature Events Coordinator. We are pleased to welcome Rog back in this capacity! For those of you who have gone on trips with him in the past...you already know what fun is in store. If you have never been on a trip with Rog – you will want to make sure you get your reservations made soon! Rog is also in charge of our Veteran’s Memorial and our Christmas in August Celebrations.

Comments, Suggestions and Questions to the Park President

Q. Does Sandy Pines provide Electrical, Plumbing and construction to our Members?

A. The short answer is No. Sandy Pines does have staff with talents in those areas, however the liability exposure to Sandy Pines for contract work such as electrical, plumbing and construction is not conducive to what we feel would be in the best interests of all Members, so we allow contractors to register with Sandy Pines. If you intend to have work done in these areas, please pick up a list of the registered contractors from the office or at the Ranger Station, or from Ralph Smith, our Inspector.

Q. Why should I use a "registered contractor" if I can save some money by using a good neighbor?

A. Each of our contractors that register with Sandy Pines must provide Sandy Pines with a current State issued contractor's license for the work that they do. Also, they must provide Workman's Comprehensive Insurance and Liability Insurance naming Sandy Pines as additional insured.

Additionally, each Registered Contractor must sign an affidavit that they have done background checks on each of their staff that will be working in the Park. The background check must include a felony background check and a felony background check that requires an individual to register on the Sex Offenders list. WARNING...If you hire a non-licensed contractor, non-insured Contractor and during the course of their working under your direction, an event occurs that harms or endangers other Members or Guests regardless of age, YOU may be the first in line to face litigation by those that have been harmed or endangered. Protect yourself and your assets. Spend the little extra and get a licensed registered contractor! The "good person" you may have doing your work without being a licensed, insured contractor may be well intended, but it will be of no help in a court of law.

Q. Where is the newspaper trailer?

A. the requirements for the acceptable paper for the company that had the trailer placed by the Retail Center became so stringent that we had very little paper collected. I think the total dollar revenue was \$60-75 for the year. The appearance of the ugly trailer wasn't worth the little revenue. I am hopeful that we can entice Paper Gator of Byron Center to put their nice green paper dumpsters in our Park. They generally have most of their dumpsters in church parking lot collection centers, but I hope they will give us a try in 2014.

Q. Why can't contractors bring grass and leaves across the street any longer?

A. In the past, the grass and leaf dump material was simply buried in the same area,

however within the last few years the area has been completely filled with buried material, causing Sandy Pines to now have it ground up and hauled off site, because we have no other place to bury it.

The average annual cost of removing this material is \$30-35,000. With an above ground storage capacity of three years, (we are now two years filled) we can expect to pay \$100,000 in 2014/15 to have this material removed. Allowing contractors to dump grass, leaves and building materials only added to the pile and shortened the allowable collection of non-contractor material with no perceptible revenue. Grass, leaf and wood material disposal will continue to be an added cost to operations long term. One of the ways we are hoping to fund these extra costs is through increasing fees for bull pen rent and boat dock rent. Certainly we are cognizant of the fact that fees must remain competitive with similar fees in the marketplace, however we will continue to search for ways to cover these new costs without raising dues.

Q. Can I Assign my Membership to my Trust?

A. Yes, you may. In late 2013, we requested a review of the Sandy Pines position pertaining to Assignments of Memberships to Trust. This was done by our Attorney, and subsequently, that review resulted in a document being developed that will protect Sandy Pines while accommodating Assignment requests. If you are interested, you may pick up a form at Member Services that must accompany the request for Assignment of your Membership to your Trust.

Q. Can there be a siren closer to Phase 3 so it can be heard if the warning sirens are activated?

A. This question came up in the Face to Phase meetings last summer also, so we looked into the cost of another siren. We found that the cost to Sandy Pines would be \$25,000 for the installation of a second siren that would likely be installed near or between Phase 6 and Phase 3, to allow better coverage for both areas. I intend to request \$25,000 in the 2014/15 budget for the installation of this unit in the next cycle. Thanks for bringing this to my attention.

Membership cards:

Membership cards are intended to facilitate access into the Park for members, their children, their parents, or designated associates and/or grandparents. If you are a Charter Member, you may recall that years ago, the Park issued two plastic membership cards for the member and paper associate cards for associate members. At that time, Members could utilize any gate, however the associate members had to enter at a manned gate. Since that time, the card gate system has evolved with technology that allows the Park entrance lines to be reduced.

Now, all members have access to all gates and certain amenities, based on their age and type of membership. With over 11,000 membership cards issued, the ability to swipe a card and have access into the Park is a much improved situation. If we still utilized the paper cards of the past, we would have long lines and additional frustrations.

Cards are issued based on a manner of trust that is expected for the benefit of Sandy Pines. Problems occur when people hand their cards to others, to utilize the Park and the Park's amenities. You may think that this doesn't hurt the Park much, "Just getting my friends in for free", but let me give you an example of a case which may help you to understand the real issues.

Last year, a member signed up a sister and brother-in-law as Associate members. First, a sister or brother-in-law cannot be associate members. Only the member(s), children, parents and grandparents and/or a designated associate, may possess membership cards. As a result of this membership purchasing an associate card for someone that was not an associate(s), the couple played golf at our golf course nine times this past summer for free. As a couple, that accounts for 18 times that golf fees were not collected. To do the math, this would be a loss to the Park of:

18 times of 9 holes played regular weekday golf x \$11 = \$198
Or 18 times of 18 holes of golf regular weekday golf x \$20 = \$360
Or 18 times of 9 holes weekend rate x \$14 = \$252
Or 18 times of 18 holes at the weekend rate x \$25 = \$450

As you can see, the Park lost between \$198 to \$450, because a couple was provided an Associate membership card, although they were not entitled to the amenity of having free golf. This is just one membership, and just one amenity. The same couple also used the fitness room and equipment.

Multiply this example towards a potential amount of just five percent of the memberships providing cards to people who are not entitled to a membership card as follows:

2,200 x .05 = 110 unentitled Associates.
Assume the 110 couples play 9 times (18 rounds of nine holes) x \$11 regular weekday golf = \$21,780 in lost Park revenue.
Assume the 110 couples play 9 times (18 rounds of eighteen holes) x \$25 weekend/holiday rate = \$49,500 in lost Park revenue.

The Park has 11,013 membership cards in its data base that have been issued to memberships. One percent of the membership card data base is 110.3. Most of these membership cards have a husband and wife, or two names on the associate card. This reduces the percentage to .05%.

In attempting to show the potential financial impact based on the above assumptions; if we were to assume that only one half of one percent of the outstanding cards were accessible to persons who are not entitled to them for the free golf only, the losses to Sandy Pines revenue for this one amenity is between \$21,780 to \$49,500.

When you knowingly register an unqualified person(s) or couple as an associate or grandchild, this act will be considered fraud and theft. The reason being that it does cost the Park revenue, increasing the financial burden to the Park membership, who corporately pay for those that commit fraud. Please be aware that in 2014 and beyond, golf and entry to all amenities will be tracked every time you swipe the card reader to play 9 or 18 holes, or if you enter any of the card access entries. If fraudulent use is suspected and/or confirmed, the Member responsible should expect to be charged for the expenses of Park usage, usage of amenities, and for golf, if you have fraudulently listed someone as a member who was not entitled to that membership
